# Introduction

The main purpose of this work is to characterize derivations through functional equations. Therefore, (besides the notion of derivations) it is natural to ask what a functional equation is. But there is no easy and satisfactory answer to this question. While such concepts as element, relation, mapping, operation, etc., are well defined in set theory, the principal concept set is an undefined term. As in set theory, we hope the reader will get a general insight of what this theory is about.

Functional equations occur almost everywhere. Their influence and applications can be felt in every field, and all fields benefit from their contact, use, and technique. The growth and development used to be influenced by their impact on other areas – not only in mathematics but also in other disciplines. Applications can be found in a wide variety of fields e.g., analysis, behavioural and social science, biology, combinatorics, economics, engineering, geometry, inequalities, information theory, physics, psychology, statistics etc.

Even though lots of mathematicians worked in this area, since the appearance of the famous monograph of J. Aczél [2] no systematic exposition existed. In this dissertation we will follow this monograph as well as that of M. Kuczma, see [54].

This work consists of five chapters. In the first one, we summarize the most important notions and results from the theory of functional equations that will be used afterwards. In Chapter 2 we collect all the definitions and results regarding derivations that are essential while studying this area. Let  $Q$  be a ring and let  $P$  be a subring of  $Q$ . A function  $f: P \rightarrow Q$  is called a *derivation* if it is additive, i.e.,

$$f(x + y) = f(x) + f(y) \quad (x, y \in P)$$

and also satisfies the so-called *Leibniz rule*, i.e., equation

$$f(xy) = f(x)y + xf(y) \quad (x, y \in P).$$

As well as homomorphisms, derivations give a lot of information about the rings between which they acts. Therefore, the characterization of derivations can also be applicable not only from the theory of functional equations but also from the point of view of some algebraic investigations. As it can be seen, the notion of derivations is already formulated via functional equations (the Cauchy equation and the Leibniz rule). In Chapter 3 we intend to show that derivations can be characterized by one single functional equation. The results of this chapter are based on Gselmann [29].

More exactly, we would like to examine whether the equations occurring in the definition of derivations are independent in the following sense.

Let  $Q$  be a commutative ring and let  $P$  be a subring of  $Q$ . Let  $\lambda, \mu \in Q \setminus \{0\}$  be arbitrary,  $f: P \rightarrow Q$  be a function and consider the equation

$$\lambda[f(x + y) - f(x) - f(y)] + \mu[f(xy) - xf(y) - yf(x)] = 0 \quad (x, y \in P).$$

Clearly, if the function  $f$  is a derivation, then this equation holds. We will however investigate the opposite direction, and it will be proved that under some assumptions on the rings  $P$  and  $Q$ , derivations can be characterized via the above equation. This result will be proved as a consequence of the main theorem that will be devoted to the equation

$$f(x + y) - f(x) - f(y) = g(xy) - xg(y) - yg(x) \quad (x, y \in P),$$

where  $f, g: P \rightarrow Q$  are unknown functions.

Chapter 4 is devoted to the additive solvability of the system of functional equations

$$d_k(xy) = \sum_{i=0}^k \Gamma(i, k-i) d_i(x) d_{k-i}(y) \quad (x, y \in \mathbb{R}, k \in \{0, \dots, n\}),$$

where  $\Delta_n := \{(i, j) \in \mathbb{Z} \times \mathbb{Z} \mid 0 \leq i, j \text{ and } i + j \leq n\}$  and  $\Gamma: \Delta_n \rightarrow \mathbb{R}$  is a symmetric function such that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$ .

Moreover, the linear dependence and independence of the additive solutions  $d_0, d_1, \dots, d_n: \mathbb{R} \rightarrow \mathbb{R}$  of the above system of equations is characterized. As a consequence of the main result, for any nonzero real derivation  $d: \mathbb{R} \rightarrow \mathbb{R}$ , the iterates  $d^0, d^1, \dots, d^n$  of  $d$  are shown to be linearly independent, and the graph of the mapping  $x \mapsto (x, d^1(x), \dots, d^n(x))$  to be dense in  $\mathbb{R}^{n+1}$ . The results of this chapter were achieved jointly with Zs. Páles and were published in [34].

Finally, the closing chapter deals with the following problem. Assume that  $\xi: \mathbb{R} \rightarrow \mathbb{R}$  is a given differentiable function and for the additive function  $f: \mathbb{R} \rightarrow \mathbb{R}$ , the mapping

$$\varphi(x) = f(\xi(x)) - \xi'(x)f(x)$$

fulfills some regularity condition (e.g. local boundedness, continuity, measurability etc.) on its domain. Is it true that in such a case  $f$  admits a representation

$$f(x) = \chi(x) + f(1) \cdot x \quad (x \in \mathbb{R}),$$

where  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a real derivation?

In case  $\varphi$  is identically zero and  $\xi(x) = x^k$ , several results are known for instance due to Jurkat [48], Kurepa [55], and Kannappan–Kurepa [49]. Our investigation in this area began in a joint work with Z. Boros, see [6]. After some preliminary results, in this chapter we will show that in case  $n \in \mathbb{Z} \setminus \{0\}$  and  $\begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \mathbf{GL}_2(\mathbb{Q})$  and the function  $\xi$  is

$$\xi(x) = \frac{ax^n + b}{cx^n + d} \quad (x \in \mathbb{R}, cx^n + d \neq 0),$$

then the answer is *affirmative*. These results can be found in [30, 31, 32]. Furthermore, we will also show that the above class of functions is expandable. More precisely, we will show (among others) the following. Assume that for the additive function  $f: \mathbb{R} \rightarrow \mathbb{R}$  the mapping  $\varphi$  defined by

$$\varphi(x) = f(\xi(x)) - \xi'(x)f(x)$$

is regular. Then the function  $f$  can be represented as

$$f(x) = \chi(x) + f(1) \cdot x \quad (x \in \mathbb{R}),$$

where  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation in any of the following cases

(a)	$\xi(x) = a^x$	(f)	$\xi(x) = \ln(x)$
(b)	$\xi(x) = \cos(x)$	(g)	$\xi(x) = \arccos(x)$
(c)	$\xi(x) = \sin(x)$	(h)	$\xi(x) = \arcsin(x)$
(d)	$\xi(x) = \cosh(x)$	(i)	$\xi(x) = \operatorname{arcosh}(x)$
(e)	$\xi(x) = \sinh(x)$	(j)	$\xi(x) = \operatorname{arsinh}(x)$ .

With the aid of Hyers' theorem and this result we were also able to prove stability type results concerning derivations.

# Chapter 1

## Preliminaries from the theory of functional equations

As J. Aczél wrote in his famous monograph [2], the theory of functional equations is one of the oldest area in mathematics. Already, J. D'Alembert, L. Euler, C.F. Gauß, A. L. Cauchy, N.H. Abel, K. Weierstraß, J.G. Darboux and D. Hilbert considered and also solved functional equations.

In this section we will summarize the most important notions and results that will be used subsequently. For the details the reader should consult the two basic monographs Aczél [2] and Kuczma [54].

### 1.1 Additive functions

Henceforth  $\mathbb{N}$ ,  $\mathbb{Z}$ ,  $\mathbb{Q}$ , and  $\mathbb{R}$  denotes the set of the natural (positive integer), the integer, the rational, and the real numbers, respectively. Furthermore  $\mathbb{R}^n$  denotes the  $n$ -dimensional Euclidean space.

A function  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  is called *additive*, if it satisfies

$$(1.1) \quad f(x + y) = f(x) + f(y)$$

for all  $x, y \in \mathbb{R}^n$ . In case  $n = 1$ , this equation was firstly investigated by A. M. Legendre and C.F. Gauß. It was however A. L. Cauchy who first found its continuous solutions. Therefore this equation has been named after him *Cauchy's equation*.

By induction, easily follows that if  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  is additive, then

$$f\left(\sum_{i=1}^k x_i\right) = \sum_{i=1}^k f(x_i)$$

is valid for all  $k \in \mathbb{N}$  and for any  $x_1, \dots, x_k \in \mathbb{R}^n$ . Furthermore, any additive function  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  is  $\mathbb{Q}$ -homogeneous as well, that is

$$f(\lambda x) = \lambda f(x)$$

is fulfilled for any  $x \in \mathbb{R}^n$  and  $\lambda \in \mathbb{Q}$ .

From this we get that if  $n = 1$  and  $f$  is continuous then

$$f(x) = f(1) \cdot x \quad (x \in \mathbb{R}).$$

For many years the existence of discontinuous additive functions was an open problem. Finally, in 1905 Hamel proved the following, see [40].

**Theorem 1.1.1** Let  $\mathcal{H}$  be a Hamel base of the space  $(\mathbb{R}^n; \mathbb{Q}; +; \cdot)$ . Then for every function  $g: \mathcal{H} \rightarrow \mathbb{R}$  there exists a unique additive function  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  such that  $f|_{\mathcal{H}} = g$ .

The above theorem gives the general construction of all the additive functions  $f: \mathbb{R}^n \rightarrow \mathbb{R}$ . Indeed, every additive  $f$  can be obtained as the unique additive extension of a certain function  $g: \mathcal{H} \rightarrow \mathbb{R}$ .

With the aid of this theorem, the following corollary can be derived immediately.

**Corollary 1.1.1** Let  $\mathcal{H}$  be a Hamel base of the space  $(\mathbb{R}^n; \mathbb{Q}; +; \cdot)$ . Let  $g: \mathcal{H} \rightarrow \mathbb{R}$  be a non-identically zero function for which

$$g(\mathcal{H}) = \{g(h) \mid h \in \mathcal{H}\} \subset \mathbb{Q}.$$

Then the additive extension  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  of  $g$  is a discontinuous additive function.

## 1.2 The remaining Cauchy equations

The following functional equations are also referred to as Cauchy's equations.

A function  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  is called an *exponential* function, if

$$(1.2) \quad f(x + y) = f(x)f(y)$$

is fulfilled for all  $x, y \in \mathbb{R}^n$ .

A function  $f: \mathbb{R} \rightarrow \mathbb{R}$  is a *logarithmic* function, if

$$(1.3) \quad f(xy) = f(x) + f(y)$$

is satisfied for all  $x, y \in \mathbb{R}$ .

Finally, a function  $f: \mathbb{R} \rightarrow \mathbb{R}$  is termed to be a *multiplicative* function, if

$$(1.4) \quad f(xy) = f(x) \cdot f(y) \quad (x, y \in \mathbb{R}).$$

**Theorem 1.2.1** Let  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  be an exponential function. Then either  $f \equiv 0$  or there is an additive function  $a: \mathbb{R}^n \rightarrow \mathbb{R}$  so that

$$f(x) = \exp(a(x)) \quad (x \in \mathbb{R}^n).$$

The natural domains of definition for logarithmic and multiplicative functions, resp. are sets of the form

$$\mathcal{L} = \{(x, y) \in A \times A \mid x \cdot y \in A\},$$

while for exponential functions, sets of the form

$$\mathcal{A} = \{(x, y) \in A \times A \mid x + y \in A\},$$

with a certain nonempty set  $A \subset \mathbb{R}$ .

**Lemma 1.2.1** Let  $A \subset \mathbb{R}$  be a nonempty set and  $f: A \rightarrow \mathbb{R}$  be a function. Assume

$$f(xy) = f(x) + f(y)$$

is valid for all  $(x, y) \in \mathcal{L}$ . If  $0 \in A$ , then  $f$  is identically zero.

**Theorem 1.2.2** Let  $A = ]0, +\infty[$  or  $A = \mathbb{R} \setminus \{0\}$ . If a function  $f: A \rightarrow \mathbb{R}$  fulfills the logarithmic Cauchy equation for all pairs  $(x, y) \in \mathcal{L}$ , then there exists an additive function  $a: \mathbb{R} \rightarrow \mathbb{R}$  such that

$$f(x) = a(\ln(|x|)) \quad (x \in A).$$

**Theorem 1.2.3** Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  be a multiplicative function. Then there exists an additive function  $a: \mathbb{R} \rightarrow \mathbb{R}$  such that  $f$  is one of the following forms.

$$f(x) = 0 \quad (x \in \mathbb{R}),$$

$$f(x) = 1 \quad (x \in \mathbb{R}),$$

$$f(x) = \begin{cases} \exp(g(\ln(|x|))) & \text{if } x \neq 0 \\ 0 & \text{if } x = 0 \end{cases}$$

$$f(x) = \begin{cases} \exp(g(\ln(|x|))) & \text{if } x > 0 \\ 0 & \text{if } x = 0 \\ -\exp(g(\ln(|x|))) & \text{if } x < 0 \end{cases}$$

### 1.3 Jensen equation and Hosszú equation

The equation resulting on replacing in the so-called Jensen inequality, i.e.,

$$f\left(\frac{x+y}{2}\right) \leq \frac{f(x)+f(y)}{2}$$

the sign of inequality by that of equality, that is,

$$(1.5) \quad f\left(\frac{x+y}{2}\right) = \frac{f(x)+f(y)}{2}$$

is known as the *Jensen equation*.

Usually (1.5) is considered for functions  $f: D \rightarrow \mathbb{R}$ , where  $D \subset \mathbb{R}^n$  is a convex set. If  $D$  were also open, then any function  $f$  fulfilling (1.5) would also be Jensen convex, and thus all the results concerning convex functions (e.g. Bernstein–Doetsch theorem) would apply. Most of these result however became invalid when the set  $D$  is not necessarily open.

**Theorem 1.3.1** *Let  $D \subset \mathbb{R}^n$  be a convex set, such that  $\text{int}(D) \neq \emptyset$  further let  $f: D \rightarrow \mathbb{R}$  be a solution of (1.5). Then there exist an additive function  $a: \mathbb{R}^n \rightarrow \mathbb{R}$  and a constant  $\alpha \in \mathbb{R}$  such that*

$$f(x) = a(x) + \alpha \quad (x \in D).$$

The functional equation

$$(1.6) \quad f(x+y-xy) + f(xy) = f(x) + f(y)$$

was mentioned for the first time by M. Hosszú in 1967 at the International Symposium on Functional Equations held in Zakopane (Poland) and it is named after him *Hosszú equation*. After its first appearance it was extensively studied by among others Blanuša [5], Daróczy [10, 8], Davison [11, 12], Davison–Redlin [14], Fenyő [19], Głowacki–Kuczma [27], Lajkó [57], Światak [65, 66, 67].

In a little while it turned out that for functions  $f: \mathbb{R} \rightarrow \mathbb{R}$  Hosszú equation and Jensen equation are *equivalent*. At the same time, even in rather simple cases it can occur that these two functional equations have a different set of general solutions. In particular, on  $\mathbb{Z}$  the function  $f: \mathbb{Z} \rightarrow \mathbb{Z}$  defined by

$$f(x) = \begin{cases} 1, & \text{if } n \text{ is even} \\ 0, & \text{if } n \text{ is odd} \end{cases} \quad (x \in \mathbb{Z}).$$

solves the Hosszú equation, however, does not solve the Jensen equation.

For functions acting between fields and commutative groups, Davison [11] proved the following.



**Theorem 1.3.2** *Let  $(G, +)$  be an abelian group and  $(\mathbb{K}, +, \cdot)$  be a field having at least five elements. Suppose that for the function  $f: \mathbb{K} \rightarrow G$  Hosszú equation satisfied, that is, we have*

$$f(x + y - xy) + f(xy) = f(x) + f(y) \quad (x, y \in \mathbb{K}).$$

Then

$$f(x) = g(x) - g(0) \quad (x \in \mathbb{K}),$$

where  $g: \mathbb{K} \rightarrow G$  is a homomorphism.

## 1.4 Polynomial functions

The study of polynomial functions defined on groups is based on the notion of multiadditive functions. Therefore, firstly we collect some basic notions and results concerning such functions. Here we follow the notations and the terminology of Székelyhidi [71, 72].

### Multiadditive functions

**Definition 1.4.1** *Let  $G, S$  be commutative semigroups,  $n \in \mathbb{N}$  and let  $A: G^n \rightarrow S$  be a function. We say that  $A$  is  $n$ -additive if it is a homomorphism of  $G$  into  $S$  in each variable. If  $n = 1$  or  $n = 2$  the function  $A$  is simply termed to be additive or biadditive, respectively. Further, letting  $G^0 = G$ , constant functions from  $G$  to  $S$  will be called 0-additive. We call the function  $A: G^n \rightarrow S$  multiadditive, if there is a natural number  $n$  such that  $A$  is  $n$ -additive.*

*The diagonalization or trace of an  $n$ -additive function  $A: G^n \rightarrow S$  is defined as*

$$A^*(x) = A([x]_n) = A(x, \dots, x) \quad (x \in G).$$

From this notion the proposition hereunder follows immediately.

**Proposition 1.4.1** *Let  $G, S$  be commutative semigroups,  $n \in \mathbb{N}$ . Then the set of all  $n$ -additive functions from  $G^n$  to  $S$  form a*

- (i) *commutative semigroup, if  $S$  is a commutative semigroup;*
- (ii) *module over the ring  $R$ , if  $S$  is a module over the ring  $R$ ;*
- (iii) *linear space over the field  $\mathbb{F}$ , if  $S$  is a linear space over  $\mathbb{F}$ .*

From the definition of multiadditive functions it follows that, if  $n \in \mathbb{N}$ , then each  $n$ -additive function  $A: G^n \rightarrow S$  satisfies

$$A(x_1, \dots, x_{i-1}, kx_i, x_{i+1}) = kA(x_1, \dots, x_{i-1}, x_i, x_{i+1}, \dots, x_n) \quad (x_1, \dots, x_n \in G)$$

for all  $i = 1, \dots, n$ , where  $k \in \mathbb{N}$  is arbitrary. Further, the same identity holds for any  $k \in \mathbb{Z}$  if  $G$  and  $S$  are groups, and for  $k \in \mathbb{Q}$ , if  $G$  and  $S$  are linear spaces over the rationals. For the diagonalization of  $A$  we have

$$A^*(kx) = k^n A^*(x) \quad (x \in G).$$

**Lemma 1.4.1 (Binomial theorem)** *Let  $G, S$  be commutative semigroups and  $n \in \mathbb{N}$ . If the function  $A: G^n \rightarrow S$  is symmetric and  $n$ -additive, then*

$$A^*(x + y) = \sum_{k=0}^n \binom{n}{k} A([x]_k, [y]_{n-k})$$

*holds for all  $x, y \in G$ .*

As a consequence of this result, the so-called *Polynomial theorem* can also be obtained.

**Lemma 1.4.2 (Polynomial theorem)** *Let  $G, S$  be commutative semigroups and  $n \in \mathbb{N}$ . If the function  $A: G^n \rightarrow S$  is symmetric and  $n$ -additive, then for any  $m \in \mathbb{N}$  and for all  $x_1, \dots, x_m \in G$*

$$A^*(x_1 + \dots + x_m) = \sum_{k_1 + \dots + k_m = n} \frac{n!}{k_1! \dots k_m!} A([x_1]_{k_1}, \dots, [x_m]_{k_m})$$

*is fulfilled.*

With the aid of the abovementioned Binomial theorem, one can also prove the so-called *Polarization formula*, that briefly expresses that (under some conditions on the domain as well as on the range) every  $n$ -additive function is *uniquely* determined by its diagonalization.

**Theorem 1.4.1 (Polarization formula)** *Let  $G$  be a commutative semigroup and  $S$  be a commutative group and  $n \in \mathbb{N}$ . If  $A: G^n \rightarrow S$  is a symmetric,  $n$ -additive function, then for all  $x, y_1, \dots, y_m \in G$  we have*

$$\Delta_{y_1, \dots, y_m} A^*(x) = \begin{cases} 0 & \text{if } m > n \\ n! A(y_1, \dots, y_m) & \text{if } m = n. \end{cases}$$

**Corollary 1.4.1** *Let  $G$  be a commutative semigroup and  $S$  be a commutative group and  $n \in \mathbb{N}$ . If  $A: G^n \rightarrow S$  is a symmetric,  $n$ -additive function, then*

$$\Delta_y^n A^*(x) = n! A^*(y) \quad (x, y \in G).$$

**Lemma 1.4.3** *Let  $G$  be a commutative semigroup and  $S$  be a commutative group and  $n \in \mathbb{N}$ . Let us assume that the multiplication by  $n!$  is surjective in  $G$  or injective in  $S$ . Then for any symmetric,  $n$ -additive function  $A: G^n \rightarrow S$ ,  $A^* \equiv 0$  implies that  $A$  is identically zero, as well.*

## Polynomial functions

The theory of polynomial functions was firstly investigated by M. Fréchet, S. Banach, G. Van der Lijn, S. Mazur, W. Orlicz, who were primary interested in polynomial operations on semigroups and linear spaces. The notion we will use is due to M. Fréchet and S. Banach. In this work we will however restrict ourselves only to the most basic notions and results, the interested reader should consult e.g. the two monographs of Székelyhidi [72, 71], Fréchet [22], Van der Lijn [73], Mazur–Orlicz [61, 62] and also Székelyhidi [68, 69].

**Definition 1.4.2** *Let  $G, S$  be commutative semigroups, a function  $p: G \rightarrow S$  is called a polynomial function, if it has a representation as the sum of diagonalizations of multiadditive functions from  $G$  to  $S$ . In other words, the function  $p: G \rightarrow S$  is a polynomial if and only if it can be written as*

$$p = \sum_{k=0}^n A_k^*,$$

*where  $n \in \mathbb{N}$ , the  $A_k: G^k \rightarrow S$  is a  $k$ -additive function for all  $k = 0, 1, \dots, n$ . In this case we also say that  $p$  is a polynomial of degree at most  $n$ .*

**Lemma 1.4.4** *Let  $G$  be a commutative semigroup and  $R$  be a ring. Then the set of all polynomials from  $G$  into the additive group of  $R$  forms a*

(i) *(commutative) ring, if  $R$  is a (commutative) ring;*

(ii) *(commutative) algebra over the field  $\mathbb{F}$ , if  $R$  is a (commutative) algebra over the field  $\mathbb{F}$ .*

**Theorem 1.4.2** *Let  $G$  be a commutative semigroup,  $S$  be a commutative group and  $n \in \mathbb{N}$ . Let us assume further the the multiplication by  $n!$  is bijective on  $G$  or on  $S$ . Then any polynomial  $p: G \rightarrow S$  of degree at most  $n$  has a unique representation in the form*

$$p = \sum_{k=0}^n A_k^*,$$

where  $A_k: G^k \rightarrow S$  is a symmetric,  $k$ -additive function for all  $k = 0, 1, \dots, n$ . Further,  $A_n$  is not identically zero, whenever  $p$  is not of degree  $n - 1$ .

Under the assumptions of the previous theorem, the given representation is called the *canonical representation* of the polynomial  $p$ , and we call  $A_k^*$  its *homogeneous term of degree  $k$* , further  $A_n^*$  is called its *leading term*, whenever it is not identically zero.

## 1.5 Extension theorems

As we will see later, it may happen that a certain functional equation does not hold on the whole possible domain but only on its subset. In this case the question is whether the functions appearing in the functional equation are extendable to the whole space so that also the functional equation is fulfilled on the whole domain.

Let  $\mathcal{G} \subset \mathbb{R}^{2n}$  be a nonempty set. In case  $p \in \mathcal{G}$ , then there are  $x, y \in \mathbb{R}^n$  so that  $p = (x, y)$ . Further, let us define the following sets.

$$\mathcal{G}_1 = \{x \in \mathbb{R}^n \mid \text{there exists } y \in \mathbb{R}^n \text{ such that } (x, y) \in \mathcal{G}\}.$$

$$\mathcal{G}_2 = \{y \in \mathbb{R}^n \mid \text{there exists } x \in \mathbb{R}^n \text{ such that } (x, y) \in \mathcal{G}\}.$$

and

$$\mathcal{G}_3 = \{x + y \in \mathbb{R}^n \mid (x, y) \in \mathcal{G}\}.$$

For the sake of brevity, we say that a set  $A \subset \mathbb{R}^n$  has the  $(\bullet)$  property, if

$$(\bullet) \quad \mathcal{G}_1 \cup \mathcal{G}_2 \cup \mathcal{G}_3 \subset A$$

is satisfied.

**Theorem 1.5.1 (Daróczy–Losonczi [9])** *Let  $\mathcal{G} \subset \mathbb{R}^{2n}$  be an open and connected set and let  $A \subset \mathbb{R}^n$  be a set having the  $(\bullet)$  property. Assume that  $f: A \rightarrow \mathbb{R}$  fulfills*

$$f(x + y) = f(x) + f(y)$$

for all  $(x, y) \in \mathcal{G}$ . Then there exists a uniquely determined additive function  $a: \mathbb{R}^n \rightarrow \mathbb{R}$  and unique constants  $\alpha, \beta \in \mathbb{R}$  such that

$$f(x) = \begin{cases} a(x) + \alpha & \text{if } x \in \mathcal{G}_1 \\ a(x) + \beta & \text{if } x \in \mathcal{G}_2 \\ a(x) + \alpha + \beta & \text{if } x \in \mathcal{G}_3 \end{cases}$$

Let  $r > 0$  then

$$B(x_0, r) = \{x \in \mathbb{R}^n \mid \|x - x_0\| < r\}$$

will denote the open ball centered at  $x_0$  with radius  $r$ .

**Corollary 1.5.1** *Let  $r > 0$  be arbitrarily fixed and  $f: B(0, 2r) \rightarrow \mathbb{R}$  be a function such that*

$$f(x + y) = f(x) + f(y)$$

*holds for all  $x, y \in B(0, r)$ . Then there exists a uniquely determined additive function such that*

$$f(x) = a(x) \quad (x \in B(0, r)).$$

In the sequel, we will use the following extension theorem concerning the so-called Pexider equation, this result is a special case of [7, Theorem 3] if we choose the normed space  $X$  to be  $\mathbb{R}^n$  and  $\mathcal{G}$  is an open and connected subset  $X \times X$ . We have to emphasize that here we do not have to suppose that some set  $A \subset \mathbb{R}^n$  has the property  $(\bullet)$ .

**Theorem 1.5.2 (Chuzdiak–Tabor)** *Assume that for the functions  $k: \mathcal{G}_3 \rightarrow \mathbb{R}$ ,  $l: \mathcal{G}_1 \rightarrow \mathbb{R}$  and  $n: \mathcal{G}_2 \rightarrow \mathbb{R}$*

$$k(x + y) = l(x) + n(y)$$

*is fulfilled for any  $x, y \in \mathcal{G}$ . If the function  $k$  is nonconstant, then these functions can uniquely be extended to functions  $\tilde{k}, \tilde{l}, \tilde{n}: \mathbb{R}^n \rightarrow \mathbb{R}$  so that*

$$\tilde{k}(x + y) = \tilde{l}(x) + \tilde{n}(y) \quad (x, y \in \mathbb{R}^n).$$

Especially, if a function  $a: \mathcal{G}_3 \rightarrow \mathbb{R}$  is additive on  $\mathcal{G}_3$ , then it can always be *uniquely* extended to an additive function  $\tilde{a}: \mathbb{R}^n \rightarrow \mathbb{R}$ . We remark that this follows also from Theorem 4 of Páles [64].

In what follows, we shall present the general solution of the Pexider equation on a restricted domain. This theorem follows immediately from [7, Theorem 1], with exactly the same choice as above.

**Theorem 1.5.3** *Assume that, for the functions  $k: \mathcal{G}_3 \rightarrow \mathbb{R}$ ,  $l: \mathcal{G}_1 \rightarrow \mathbb{R}$  and  $n: \mathcal{G}_2 \rightarrow \mathbb{R}$ ,*

$$k(x + y) = l(x) + n(y)$$

*is fulfilled for any  $x, y \in \mathcal{G}$  and that the function  $k$  is nonconstant. Then and only then there exists a uniquely determined additive function  $a: \mathbb{R}^n \rightarrow \mathbb{R}$  and real constants  $b$  and  $c$  so that*

$$\begin{aligned} k(x) &= a(x) + b + c \\ l(x) &= a(x) + b \\ n(x) &= a(x) + c \end{aligned} \quad (x \in \mathbb{R}^n).$$

Finally, the following statement concerns the constant solutions of the Pexider equation.

**Corollary 1.5.2** *Let  $k \in \mathbb{R}$  be fixed and  $l: \mathcal{G}_1 \rightarrow \mathbb{R}$  and  $n: \mathcal{G}_2 \rightarrow \mathbb{R}$  be functions so that*

$$k = l(x) + n(y)$$

*is fulfilled for all  $x, y \in \mathcal{G}$ . Then there exists  $c \in \mathbb{R}$  such that*

$$n(x) = c \quad \text{and} \quad l(x) = k - c \quad (x \in \mathcal{G}).$$

## 1.6 Regularity theorems

In this subsection a few so-called regularity results will be presented. Without limitation to completeness, here we list only those result that will be utilized later. For further results we refer to the monograph [46] of A. Járαι and also to the two monographs [71, 72] of L. Székelyhidi as well as Székelyhidi [70].

The first classical results in the regularity theory of functional equations concerned mostly with additive functions. Later these results have been extended to multiadditive and polynomial functions, respectively.

We begin with the description of continuous, respectively measurable additive functions, see Kuczma [54].

**Theorem 1.6.1** *Let  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  be a continuous additive function. Then there exists a uniquely determined  $\lambda = (\lambda_1, \dots, \lambda_n) \in \mathbb{R}^n$  such that*

$$f(x) = \langle \lambda, x \rangle = \sum_{k=1}^n \lambda_k x_k \quad (x = (x_1, \dots, x_n) \in \mathbb{R}^n)$$

*holds.*

**Theorem 1.6.2 (Fréchet [20, 21])** *Let  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  be an additive function which is measurable in the sense of Lebesgue. Then  $f$  is continuous.*

**Theorem 1.6.3** *Let  $f: \mathbb{R}^n \rightarrow \mathbb{R}$  be an additive function. Assume that there exists a set  $A \subset \mathbb{R}^n$  with positive Lebesgue measure such that the restriction of the function  $f$  to this set  $A$  is a function that is bounded above or below. Then  $f$  is a continuous additive function.*

The following theorem (see also Kuczma [54, Theorem 13.4.3]) is about continuous multiadditive functions.

**Theorem 1.6.4** *Let us assume that the  $p$ -additive function  $f: \mathbb{R}^{np} \rightarrow \mathbb{R}$  is a continuous  $p$ -additive function. Then there exist constants  $c_{j_1, \dots, j_p} \in \mathbb{R}$ ,  $j_1, \dots, j_p = 1, \dots, N$ , such that*

$$f(x_1, \dots, x_p) = \sum_{j_1=1}^N \cdots \sum_{j_p=1}^N c_{j_1, \dots, j_p} x_{j_1} \cdot x_{j_p},$$

*where  $(i_i) = (x_{i_1}, \dots, x_{i_n})$ ,  $i = 1, \dots, p$ .*

The results presented below show that in general mild regularity conditions on polynomials imply their continuity. Here we lean on the two monographs Székelyhidi [71, 72].

**Theorem 1.6.5** *Let  $G$  be a commutative semigroup and  $X$  be a locally convex topological vector space. Then any bounded polynomial  $p: G \rightarrow X$  is constant.*

**Theorem 1.6.6** *Let  $G$  be a locally compact commutative group which is generated by any neighbourhood of zero and let  $X$  be a linear space. If a polynomial  $p: G \rightarrow X$  vanishes on a measurable set of positive measure, then it vanishes everywhere.*

The result below is about continuous polynomials, see Theorem 3.2 of [71], as well.

**Theorem 1.6.7** *Let  $G$  be a locally compact commutative group which is generated by any neighbourhood of zero and let  $X$  be a locally convex topological linear space. If a polynomial  $p: G \rightarrow X$  is continuous at a point, then it is continuous everywhere.*

The following three statement will play a key role in Chapter 5, they can also be found in Székelyhidi [71] as Theorems 3.7, 3.8 and 3.9.

**Theorem 1.6.8** *Let  $G$  be a locally compact commutative group which is generated by any neighbourhood of zero and let  $X$  be a locally convex topological linear space. If a polynomial  $p: G \rightarrow X$  is bounded on a nonvoid open set, then it is continuous everywhere.*

**Theorem 1.6.9** *Let  $G$  be a locally compact commutative group which is generated by any neighbourhood of zero and let  $X$  be a locally convex topological linear space. If a polynomial  $p: G \rightarrow X$  is bounded on a measurable set of positive measure, then it is continuous everywhere.*

**Theorem 1.6.10** *Let  $G$  be a locally compact commutative group which is generated by any neighbourhood of zero and let  $X$  be a locally convex and locally bounded topological linear space. If a polynomial  $p: G \rightarrow X$  is measurable on a measurable set of positive measure, then it is continuous everywhere.*

# Chapter 2

## Derivations

The main aim of this work is to present some characterization theorems concerning derivations. Thus, at first, we list some preliminary results that will be used in the sequel. All of these statements and definitions can be found in Kuczma [54] and in Zariski–Samuel [74] and also in Kharchenko [52].

Since this work is about derivations, we endeavour to be as self-contained as it is possible concerning derivations. Therefore, in this section most of the statements are presented with proofs. For more results see Chapter 14 of Kuczma [54].

### 2.1 Derivations

**Definition 2.1.1** *Let  $Q$  be a ring and let  $P$  be a subring of  $Q$ . A function  $f: P \rightarrow Q$  is called a derivation if it is additive, i.e.,*

$$f(x + y) = f(x) + f(y) \quad (x, y \in P)$$

*and also satisfies the so-called Leibniz rule, i.e., equation*

$$f(xy) = f(x)y + xf(y) \quad (x, y \in P).$$

From the above definition, the following proposition follows immediately.

**Proposition 2.1.1** *Let  $Q$  be a ring and let  $P$  be a subring of  $Q$ , and let  $f, g: P \rightarrow Q$  be derivations and  $\alpha, \beta \in P$ . Then*

- (i) *the function  $\alpha f + \beta g$  is also a derivation;*
- (ii) *the function  $f\alpha + g\beta$  is also a derivation;*
- (iii) *assuming that  $Q = P$ , the function  $f \circ g$  is a derivation, if and only if either  $f \equiv 0$  or  $g \equiv 0$ ;*
- (iv) *assuming that  $Q = P$ , the bracket of  $f$  and  $g$ , that is,*

$$[f, g] = f \circ g - g \circ f$$

*is also a derivation.*

The set of derivations of the ring  $R$  will be denoted through  $\text{Der}(R)$ , that is,

$$\text{Der}(R) = \{f: R \rightarrow R \mid f \text{ is a derivation}\}.$$

In view of the above proposition, this set is closed relative to the bracket operator. Therefore,  $\text{Der}(R)$  is a Lie ring, which is simultaneously a right module over the center of the ring  $R$ , provided that the multiplication by the central elements is determined by the formula

$$(f \cdot z)(x) = f(x)z \quad (x \in R, z \in Z(R)),$$

where  $Z(R)$  denotes the center of the ring  $R$ .

At the same time, one cannot claim that  $\text{Der}(R)$  is an algebra over the ring  $Z(R)$ , since the definition of an algebra includes the identity

$$[f \cdot z, g] = [f, g] \cdot z \quad (f, g \in \text{Der}(R), z \in Z(R)),$$

while in the ring  $\text{Der}(R)$  the following identity holds instead

$$[f \cdot z, g] = [f, g] \cdot z + f \cdot g(z) \quad (f, g \in \text{Der}(R), z \in Z(R)).$$

Among derivations, as well as among automorphisms, one can single out a so-called inner part.

**Definition 2.1.2** Let  $R$  be a ring and  $b \in R$ , then the mapping  $\text{ad}_b: R \rightarrow R$  defined by

$$\text{ad}_b(x) = [x, b] \quad (x \in R)$$

is a derivation. A derivation  $f: R \rightarrow R$  is termed to be an inner derivation if there is a  $b \in R$  so that  $f \equiv \text{ad}_b$ . We say that a derivation is an outer derivation if it is not inner.

Clearly, commutative rings admit only *trivial* inner derivations.

A fundamental example for derivations is the following.

**Example 2.1.1** Let  $\mathbb{F}$  be a field, and let in the above definition  $P = Q = \mathbb{F}[x]$  be the ring of polynomials with coefficients from  $\mathbb{F}$ . For a polynomial  $p \in \mathbb{F}[x]$ ,  $p(x) = \sum_{k=0}^n a_k x^k$ , define the function  $f: \mathbb{F}[x] \rightarrow \mathbb{F}[x]$  as

$$f(p) = p',$$

where  $p'(x) = \sum_{k=1}^n k a_k x^{k-1}$  is the derivative of the polynomial  $p$ . Then the function  $f$  clearly fulfills

$$f(p + q) = f(p) + f(q)$$

and

$$f(pq) = pf(q) + qf(p)$$

for all  $p, q \in \mathbb{F}[x]$ . Hence  $f$  is a derivation.

**Example 2.1.2** Let  $(\mathbb{F}, +, \cdot)$  be a field, and suppose that we are given a derivation  $f: \mathbb{F} \rightarrow \mathbb{F}$ . We define the mapping  $f_0: \mathbb{F}[x] \rightarrow \mathbb{F}[x]$  in the following way. If  $p \in \mathbb{F}[x]$  has the form

$$p(x) = \sum_{k=0}^n a_k x^k,$$



then let

$$f_0(p) = p^f(x) = \sum_{k=0}^n f(a_k)x^k.$$

Then  $f_0: \mathbb{F}[x] \rightarrow \mathbb{F}[x]$  is a derivation.

Indeed, let  $q \in \mathbb{F}[x]$ ,  $q(x) = \sum_{k=0}^n b_k x^k$ . Note, that without the loss of generality we may assume that both sum goes from zero to  $n$ , adding to that of the smaller degree terms with coefficients zero. In this case

$$f_0(p + q) = \sum_{k=0}^n (a_k + b_k)x^k = \sum_{k=0}^n a_k x^k + \sum_{k=0}^n f(b_k)x^k = f_0(p) + f_0(q),$$

thus  $f_0$  is additive.

Since  $pq = \sum_{k=0}^{2n} \left( \sum_{i=0}^k a_i b_{k-i} \right) x^k$ , due to the additivity of  $f_0$ , we have

$$\begin{aligned} f_0(pq) &= f_0 \left( \sum_{k=0}^{2n} \left( \sum_{i=0}^k a_i b_{k-i} \right) x^k \right) = \sum_{k=0}^{2n} f \left( \sum_{i=0}^k a_i b_{k-i} \right) x^k = \sum_{k=0}^{2n} \left( \sum_{i=0}^k f(a_i b_{k-i}) \right) x^k \\ &= \sum_{k=0}^{2n} \left( \sum_{i=0}^k f(a_i) b_{k-i} + a_i f(b_{k-i}) \right) x^k = \sum_{k=0}^{2n} \left( \sum_{i=0}^k a_i f(b_{k-i}) \right) x^k + \sum_{k=0}^{2n} \left( \sum_{i=0}^k a_i f(b_{k-i}) \right) x^k \\ &= p f_0(q) + f_0(p)q. \end{aligned}$$

The following lemma says that the above two examples have rather fundamental importance.

**Lemma 2.1.1** Let  $(\mathbb{K}, +, \cdot)$  be a field and let  $(\mathbb{F}, +, \cdot)$  be a subfield of  $\mathbb{K}$ . If  $f: \mathbb{F} \rightarrow \mathbb{K}$  is a derivation, then for any  $a \in \mathbb{F}$  and for arbitrary polynomial  $p \in \mathbb{F}[x]$  we have

$$f(p(a)) = p^f(a) + f(a)p'(a).$$

**Proof.** At first we will show that for any  $k \in \mathbb{N}$

$$f(a^k) = k a^{k-1} f(a)$$

is fulfilled. This is evident for  $k = 1$ . Assuming that the above identity is valid for some  $k \in \mathbb{N}$ ,

$$f(a^{k+1}) = f(a \cdot a^k) = f(a)a^k + a f(a^k) = a^k f(a) + a \cdot k a^{k-1} f(a) = (k+1)a^k f(a).$$

Therefore, the above identity holds for any  $k \in \mathbb{N}$ .

From the Leibniz rule we have

$$f(1 \cdot 1) = 1 \cdot f(1) + f(1) \cdot 1 = 2f(1),$$

implying  $f(1) = 0$ .

Let now  $p(x) = \sum_{k=0}^n a_k x^k$ , then

$$\begin{aligned} f(p(a)) &= f \left( \sum_{k=0}^n a_k a^k \right) = \sum_{k=0}^n f(a_k a^k) = \sum_{k=0}^n f(a_k) a^k + \sum_{k=0}^n a_k f(a^k) \\ &= p^f(a) + \sum_{k=0}^n a_k k a^{k-1} f(a) = p^f(a) + f(a)p'(a), \end{aligned}$$

which proves the lemma. □

From the previous lemma we know that  $f(1) = 0$ . On the other hand every real additive function is  $\mathbb{Q}$ -homogeneous. Thus we have the following.

**Lemma 2.1.2** *If  $f: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation, then  $f(x) = 0$  for all  $x \in \mathbb{Q}$ .*

This lemma and Lemma 2.1.1 implies the following statement.

**Lemma 2.1.3** *If  $f: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation, then  $f(x) = 0$  is fulfilled for arbitrary  $x \in \text{algcl}(\mathbb{Q})$ .*

**Proof.** Assume  $a \in \text{algcl}(\mathbb{Q})$  and let  $p \in \mathbb{Q}[x]$  the minimal polynomial of  $a$ . Let  $p(x) = \sum_{k=0}^n a_k x^k$ . Here  $a_k \in \mathbb{Q}$  for all  $k = 0, 1, \dots, n$ . Applying Lemma 2.1.2, we have

$$f(a_k) = 0 \quad (k = 0, 1, \dots, n).$$

Whence

$$p^f(x) = \sum_{k=0}^n f(a_k) x^k = 0.$$

In view of Lemma 2.1.1 this means that

$$f(p(a)) = f(a)p'(a).$$

Since  $p(a) = 0$ , from this we get that  $f(p(a)) = 0$ . So  $f(a)$  or  $p'(a)$  is zero. However, due to the minimality of  $p$ , inequality  $\deg(p') < \deg(p)$  holds, yielding that  $p'(a) \neq 0$ . Thus  $f(a) = 0$ .  $\square$

From the additive property of derivations, we have also the following.

**Theorem 2.1.1** *Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  be a derivation and suppose that at least one of the following is fulfilled:*

- (i)  *$f$  is measurable;*
- (ii)  *$f$  is bounded above on a set of positive Lebesgue measure;*
- (iii)  *$f$  is bounded below on a set of positive Lebesgue measure.*

*Then  $f$  is identically zero.*

## 2.2 Extensions of derivations

In the present section we study the possibility of extending a derivation from its domain of definition onto a larger algebraic structure.

**Lemma 2.2.1** *Let  $(P, +, \cdot)$  be an integral domain, let  $(\mathbb{F}, +, \cdot)$  be its field of fractions, and let  $(\mathbb{K}, +, \cdot)$  be a field so that  $P \subset \mathbb{F} \subset \mathbb{K}$  is fulfilled. If  $f: P \rightarrow \mathbb{K}$  is a derivation, then there exists a unique derivation  $g: \mathbb{F} \rightarrow \mathbb{K}$  such that  $g|_P = f$ .*

**Proof.** Every  $x \in \mathbb{F}$  can be written as  $x = u/v$ , where  $u, v \in P, v \neq 0$ . For such an  $x$  we put

$$(2.1) \quad g(x) = g\left(\frac{u}{v}\right) = \frac{vf(u) - uf(v)}{v^2}.$$

We must check that this definition is unambiguous, i.e., if  $u/v = z/w, v, w \neq 0$ , then  $g(u/v) = g(z/w)$ . Now,  $u/v = z/w$  means

$$(2.2) \quad uw = vz,$$

whence by the Leibniz rule  $uf(w) + wf(u) = vf(z) + zf(v)$ , i.e.,

$$vf(z) - uf(w) = wf(u) - zf(v).$$

Multiplying this by  $uw$  we get

$$v^2wf(z) - uvwf(w) = vw^2f(u) - zvzf(v),$$

or, by (2.2)

$$v^2wf(z) - v^2zf(w) = vw^2f(u) - uw^2f(v).$$

Dividing this by  $v^2w^2$  we obtain

$$\frac{wf(z) - zf(w)}{w^2} = \frac{vf(u) - uf(v)}{v^2},$$

i.e.,  $g(z/w) = g(u/v)$ . Thus expression (2.1) does not depend on the representation of  $x$  as a fraction  $u/v$ .

Now take arbitrary  $x, y \in \mathbb{F}, x = u/v, y = z/w, u, v, z, w \in P, v, w \neq 0$ . Then using the additivity and the Leibniz rule,

$$\begin{aligned} g(x + y) &= g\left(\frac{u}{v} + \frac{z}{w}\right) = g\left(\frac{uw + zv}{vw}\right) = \frac{vwf(uw + zv) - (uw + zv)f(uw)}{v^2w^2} = \\ &= \frac{vw(uf(w) + wf(u) + zf(v) + vf(z)) - (uw + zv)(vf(w) + wf(v))}{v^2w^2} = \\ &= \frac{vw^2f(u) + v^2wf(z) - uw^2f(v) - zv^2f(w)}{v^2w^2} = \\ &= \frac{vf(u) - uf(v)}{v^2} + \frac{wf(z) - zf(w)}{w^2} = g\left(\frac{u}{v}\right) + g\left(\frac{z}{w}\right) = \\ &= g(x) + g(y), \end{aligned}$$

and

$$\begin{aligned} g(xy) &= g\left(\frac{uz}{vw}\right) = \frac{vwf(uz) - uzf(vw)}{v^2w^2} = \\ &= \frac{vw(uf(z) + zf(u)) - uz(vf(w) + wf(v))}{v^2w^2} = \\ &= \frac{uv(wf(z) - zf(w)) + zw(vf(u) - uf(v))}{v^2w^2} = \\ &= \frac{u}{v} \frac{wf(z) - zf(w)}{w^2} + \frac{z}{w} \frac{vf(u) - uf(v)}{v^2} = \\ &= \frac{u}{v} g\left(\frac{z}{w}\right) + \frac{z}{w} g\left(\frac{u}{v}\right) = xg(y) + yg(x). \end{aligned}$$

Consequently  $g$  is a derivation of  $\mathbb{F}$ . If  $x \in P$ , then  $x = x/1$  and bearing in mind that  $f(1) = 0$ ,

$$g(x) = g\left(\frac{x}{1}\right) = \frac{f(x) - xf(1)}{1} = f(x),$$

i.e.,  $g|_P = f$ .

Now let  $g: \mathbb{F} \rightarrow \mathbb{K}$  be an arbitrary derivation such that  $g|_P = f$ . Take an arbitrary  $x \in \mathbb{F}$ ,  $x = u/v$ ,  $u, v \in P$ ,  $v \neq 0$ . We have  $f(u) = g(u) = g(vx) = vg(x) + xg(v) = vg(x) + xf(v)$ , whence

$$g(x) = \frac{f(u) - xf(v)}{v} = \frac{vf(u) - uf(v)}{v^2}.$$

This means that  $g$  has form (2.1), which proves the uniqueness of the extension.  $\square$

**Lemma 2.2.2** *Let  $(\mathbb{K}, +, \cdot)$  be a field, let  $(\mathbb{F}, +, \cdot)$  be a subfield of  $(\mathbb{K}, +, \cdot)$ , and let  $f: \mathbb{F} \rightarrow \mathbb{K}$  be a derivation. Further, let  $a, u \in \mathbb{K}$ . There exists a derivation  $g: \mathbb{F}(a) \rightarrow \mathbb{K}$  such that  $g|_{\mathbb{F}} = f$  and  $g(a) = u$  if and only if*

$$(2.3) \quad r^f(a) + ur'(a) = 0$$

for every  $r \in \mathbb{F}[x]$  such that  $r(a) = 0$ . If it exists, the extension  $g$  is unique.

**Lemma 2.2.3** *Let  $(\mathbb{K}, +, \cdot)$  be a field, let  $(\mathbb{F}, +, \cdot)$  be a subfield of  $(\mathbb{K}, +, \cdot)$  and let  $S \subset \mathbb{K}$  algebraically independent over  $\mathbb{F}$ . Let  $f: \mathbb{F} \rightarrow \mathbb{K}$  be a derivation, and let  $u: S \rightarrow \mathbb{K}$  be an arbitrary function. Then there exists a unique derivation  $g: \mathbb{F}(S) \rightarrow \mathbb{K}$  such that  $g|_{\mathbb{F}} = f$  and  $g|_S = u$ .*

**Proof.** Let  $\mathcal{R}$  be the collection of all couples  $(S_\alpha, g_\alpha)$  such that  $S_\alpha \subset S$ ,  $g_\alpha: \mathbb{F}(S_\alpha) \rightarrow \mathbb{K}$  is a derivation, and  $g_\alpha|_{\mathbb{F}} = f$ ,  $g_\alpha|_{S_\alpha} = u$ . The couple  $(\emptyset, f) \in \mathcal{R}$  so that  $\mathcal{R} \neq \emptyset$ . We order  $\mathcal{R}$  as follows:  $(S_\alpha, g_\alpha) \leq (S_\beta, g_\beta)$  if and only if  $S_\alpha \subset S_\beta$  and  $g_\beta|_{\mathbb{F}(S_\alpha)} = g_\alpha$ . Thus  $(\mathcal{R}, \leq)$  is an ordered set, and if  $\mathcal{L} \subset \mathcal{R}$  is a chain, then the couple  $(S_0, g_0)$  such that  $S_0 = \bigcup_{(S_\alpha, g_\alpha) \in \mathcal{L}} S_\alpha$ ,  $g_0|_{\mathbb{F}(S_\alpha)} = g_\alpha$  for  $(S_\alpha, g_\alpha) \in \mathcal{L}$ , is an upper bound of  $\mathcal{L}$  in  $\mathcal{R}$ . By the Lemma of Kuratowski–Zorn there exists a maximal element  $(S_{\max}, g_{\max})$  in  $\mathcal{R}$ . Thus, in particular,  $S_{\max} \subset S$ . Suppose that there exists an  $a \in S \setminus S_{\max}$ . Since  $S$  is algebraically independent over  $\mathbb{F}$  and  $a \in S \setminus S_{\max}$ , we have  $r(a) \neq 0$  for every  $r \in \mathbb{F}(S_{\max})[x]$ . So the condition in Lemma 2.2.2 is trivially fulfilled. Thus the derivation  $g_{\max}$  can be extended onto  $\mathbb{F}(S_{\max})(a)$  to a derivation  $g^*: \mathbb{F}(S_{\max})(a) \rightarrow \mathbb{K}$  such that  $g^*|_{\mathbb{F}(S_{\max})} = g_{\max}$ ,  $g^*(a) = u(a)$ . Hence  $g^*$  satisfies  $g^*|_{\mathbb{F}} = g^*|_{\mathbb{F}(S_{\max})}|_{\mathbb{F}} = g_{\max}|_{\mathbb{F}} = f$ ,  $g^*|_{S_{\max}} = g_{\max}|_{S_{\max}} = u$ , whence  $g^*|_{(S_{\max} \cup \{a\})} = u$ . Writing  $S^* = S_{\max} \cup \{a\}$  we obtain hence that  $(S^*, g^*) \in \mathcal{R}$  and  $(S_{\max}, g_{\max}) < (S^*, g^*)$ , which contradicts the maximality of  $(S_{\max}, g_{\max})$ .

Consequently  $S_{\max} = S$ , and  $g = g_{\max}$  is the required extension.

It remains to prove the uniqueness. Let  $x \in \mathbb{F}(S)$ . Then there exists a finite set  $S_1 = \{a_1, \dots, a_n\} \subset S$  such that  $x \in \mathbb{F}(S_1)$ . But

$$\mathbb{F}(S_1) = \mathbb{F}(a_1)(a_2) \cdots (a_n).$$

Since, by Lemma 2.2.2, the extension of a derivation onto a simple extension of its field of definition (with the prescribed value at the element by which we extend the basic field) is unique,  $g$  is uniquely determined on  $\mathbb{F}(a_1) \cdots (a_k)$  for every  $k = 1, \dots, n$ , and so, in particular,  $g(x)$  is uniquely determined. Thus  $g$  is uniquely determined at every point  $x \in \mathbb{F}(S)$ , and so  $g$  is unique.  $\square$

**Lemma 2.2.4** *Let  $(\mathbb{K}, +, \cdot)$  be a field of characteristic zero, let  $(\mathbb{K}_1, +, \cdot)$  be a subfield of  $(\mathbb{K}, +, \cdot)$ , and let  $(\mathbb{F}, +, \cdot)$  be a subfield of  $(\mathbb{K}_1, +, \cdot)$  such that  $\mathbb{K}_1 \subset \text{alg cl}(\mathbb{F})$ . Let  $f: \mathbb{F} \rightarrow \mathbb{K}$  be a derivation. Then there exists a unique derivation  $g: \mathbb{K}_1 \rightarrow \mathbb{K}$  such that  $g|_{\mathbb{F}} = f$ .*

**Proof.** Let  $\mathcal{R}$  be the collection of all couples  $(\mathbb{K}_\alpha, g_\alpha)$  such that  $(\mathbb{K}_\alpha, +, \cdot)$  is a subfield of  $(\mathbb{K}_1, +, \cdot)$ ,  $\mathbb{F} \subset \mathbb{K}_\alpha$ ,  $g_\alpha: \mathbb{F} \rightarrow \mathbb{K}$  is a derivation and  $g_\alpha|_{\mathbb{F}} = f$ .  $(\mathbb{F}, f) \in \mathcal{R}$ , so  $\mathcal{R} \neq \emptyset$ . We order  $\mathcal{R}$  similarly as in the previous proof.  $(\mathbb{K}_\alpha, g_\alpha) \leq (\mathbb{K}_\beta, g_\beta)$  if and only if  $(\mathbb{K}_\alpha, +, \cdot)$  is a subfield of  $(\mathbb{K}_\beta, +, \cdot)$  and  $g_\beta|_{\mathbb{K}_\alpha} = g_\alpha$ . Then  $(\mathcal{R}, \leq)$  is an ordered set, and as previously we verify that every chain in  $\mathcal{R}$  has an upper bound  $(K_0, g_0) \in \mathcal{R}$ . Again, be the Lemma of Kuratowski–Zorn, there exists in  $\mathcal{R}$  a maximal element  $(\mathbb{K}_{\max}, g_{\max})$ . In particular,  $(\mathbb{K}_{\max}, +, \cdot)$  is a subfield of  $(\mathbb{K}_1, +, \cdot)$ . Suppose that there exists an  $a \in \mathbb{K}_1 \setminus \mathbb{K}_{\max}$ . Thus  $a$  is algebraic over  $\mathbb{F}$ , and let  $p \in \mathbb{F}[x]$  be its minimal polynomial. We have  $p' \neq 0$ , since the characteristic of  $\mathbb{K}$  is zero (whence also the characteristic of  $\mathbb{F}$  is zero), whence  $p'(a) \neq 0$ , since  $\text{degree } p' < \text{degree } p$ , and  $p$  is the minimal polynomial of  $a$ . Put  $u = -p^{g_{\max}}(a)/p'(a)$ , and let  $r \in \mathbb{K}_{\max}[x]$  be a polynomial such that  $r(a) = 0$ . There exist polynomials  $q, s \in \mathbb{K}_{\max}[x]$  such that  $r = qp + s$  and  $\text{degree } s < \text{degree } p$ . Hence  $0 = r(a) = q(a)p(a) + s(a) = s(a)$ , whence it follows that  $s = 0$ , and  $r = qp$ . Now

$$\begin{aligned} r^{g_{\max}}(a) + ur'(a) &= q(a)p^{g_{\max}}(a) + p(a)q^{g_{\max}}(a) + up'(a)q(a) + up(a)q'(a) = \\ &= q(a)(p^{g_{\max}}(a) + up'(a)), \end{aligned}$$

since  $p(a) = 0$ . By the choice of  $u$  we have  $p^{g_{\max}}(a) + up'(a) = 0$ , whence also  $r^{g_{\max}}(a) + ur'(a) = 0$ .

By Lemma 2.2.2 there exists a derivation  $g^*: \mathbb{K}_{\max}(a) \rightarrow \mathbb{K}$  such that  $g^*|_{\mathbb{K}_{\max}} = g_{\max}$ . Write  $\mathbb{K}^* = \mathbb{K}_{\max}(a)$ . Since  $\mathbb{K}_{\max} \subset \mathbb{K}_1$  and  $a \in \mathbb{K}_1$ , the field  $(\mathbb{K}^*, +, \cdot)$  is a subfield of  $(\mathbb{K}_1, +, \cdot)$ , and, of course,  $\mathbb{F} \subset \mathbb{K}_{\max} \subset \mathbb{K}^*$ . Moreover,  $g^*|_{\mathbb{F}} = g_{\max}|_{\mathbb{F}} = f$ . Thus  $(\mathbb{K}^*, g^*) \in \mathcal{R}$ , and  $(\mathbb{K}_{\max}, g_{\max}) < (\mathbb{K}^*, g^*)$ , which contradicts the maximality of  $(\mathbb{K}_{\max}, g_{\max})$ . Hence  $\mathbb{K}_{\max} = \mathbb{K}_1$ , and  $g = g_{\max}$  is the desired extension.

To prove uniqueness, suppose that  $g: \mathbb{K}_1 \rightarrow \mathbb{K}$  is a derivation such that  $g|_{\mathbb{F}} = f$ . Take an  $a \in \mathbb{K}_1$ . Let  $p \in \mathbb{F}[x]$  be the minimal polynomial of  $a$ . As we have seen above, we have  $p'(a) \neq 0$ . By Lemma 2.1.1

$$p^f(a) + g(a)p'(a) = p^g(a) + g(a)p'(a) = g(p(a)) = g(0) = 0.$$

Hence  $g(a) = -p^f(a)/p'(a)$  is uniquely determined. Thus all the values of  $g$  on  $\mathbb{K}_1$  are uniquely determined, whence  $g$  is unique.  $\square$

**Theorem 2.2.1** *Let  $(\mathbb{K}, +, \cdot)$  be a field of characteristic zero, let  $(\mathbb{F}, +, \cdot)$  be a subfield of  $(\mathbb{K}, +, \cdot)$ , let  $S$  be an algebraic base of  $\mathbb{K}$  over  $\mathbb{F}$ , if it exists, and let  $S = \emptyset$  otherwise. Let  $f: \mathbb{F} \rightarrow \mathbb{K}$  be a derivation. Then, for every function  $u: S \rightarrow \mathbb{K}$ , there exists a unique derivation  $g: \mathbb{K} \rightarrow \mathbb{K}$  such that  $g|_{\mathbb{F}} = f$  and  $g|_S = u$ .*

**Proof.** If  $\mathbb{K} = \text{alg cl}(\mathbb{F})$ , this results from Lemma 2.2.4. (Then  $S = \emptyset$ , and there is no  $u$  involved). If  $\mathbb{K} \neq \text{alg cl}(\mathbb{F})$ , then there exists an algebraic base  $S$  of  $\mathbb{K}$  over  $\mathbb{F}$  so that  $\text{alg cl}(\mathbb{F}(S)) = \mathbb{K}$ . Since  $S$  is algebraically independent over  $\mathbb{F}$ , by Lemma 2.2.3 there exists a unique derivation  $g_0: \mathbb{F}(S) \rightarrow \mathbb{K}$  such that  $g_0|_{\mathbb{F}} = f$  and  $g_0|_S = u$ . By Lemma 2.2.4 the derivation  $g_0$  can be uniquely extended onto  $\text{alg cl}(\mathbb{F}(S)) = \mathbb{K}$  to a derivation  $g: \mathbb{K} \rightarrow \mathbb{K}$  such that  $g|_{\mathbb{F}(S)} = g_0$ , whence  $g|_{\mathbb{F}} = g|_{\mathbb{F}(S)}|_{\mathbb{F}} = g_0|_{\mathbb{F}} = f$ , and  $g|_S = g|_{\mathbb{F}(S)}|_S = g_0|_S = u$ .  $\square$

**Theorem 2.2.2** *There exist non-trivial derivations of  $\mathbb{R}$ .*

**Proof.** We have  $\mathbb{R} \neq \text{alg cl}(\mathbb{Q})$ , so there exists an algebraic base of  $\mathbb{R}$  over  $\mathbb{Q}$ . Let  $u: S \rightarrow \mathbb{R}$  be an arbitrary function,  $u \neq 0$ . The characteristic of  $\mathbb{R}$  is zero. Now take in Theorem 2.2.1  $\mathbb{F} = \mathbb{Q}$  and  $\mathbb{K} = \mathbb{R}$ . The trivial derivation  $f_0: \mathbb{Q} \rightarrow \mathbb{R}$ ,  $f_0 = 0$ , can, by Theorem 2.2.1, be uniquely extended onto  $\mathbb{R}$  to a derivation  $f: \mathbb{R} \rightarrow \mathbb{R}$  such that  $f|_S = u$ , whence  $f \neq 0$ .  $\square$

Incidentally, in this way we have obtained a description of all the derivations of  $\mathbb{R}$ . Every such derivation can be arbitrarily prescribed on an algebraic base  $S$  of  $\mathbb{R}$  over  $\mathbb{Q}$ , and then it is already uniquely determined.

## 2.3 Relations between additive functions

Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  be a derivation, and let  $x \in \mathbb{R} \setminus \{0\}$ . We have by Lemma 2.1.2

$$0 = f(1) = f\left(x \frac{1}{x}\right) = xf\left(\frac{1}{x}\right) + \frac{1}{x}f(x),$$

whence

$$(2.4) \quad f(x) = -x^2 f\left(\frac{1}{x}\right).$$

We will show that this relation characterizes derivations among additive functions  $f: \mathbb{R} \rightarrow \mathbb{R}$ .

**Theorem 2.3.1** *Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  be an additive function satisfying condition (2.4) for all  $x \in \mathbb{R} \setminus \{0\}$ . Then  $f$  is a derivation.*

**Proof.** Take an arbitrary  $x \in \mathbb{R}$ ,  $x \neq 0, 1, -1$ . Then we have by (2.4) and by the additivity of  $f$  that

$$\begin{aligned} f(x) + \frac{1}{x^2}f(x) &= f(x) - f\left(\frac{1}{x}\right) = f\left(x - \frac{1}{x}\right) = f\left(\frac{x^2 - 1}{x}\right) = \\ &= -\left(\frac{x^2 - 1}{x}\right)^2 f\left(\frac{x}{x^2 - 1}\right) = -\left(\frac{x^2 - 1}{x}\right)^2 f\left(\frac{1}{x-1} - \frac{1}{x^2 - 1}\right) = \\ &= -\left(\frac{x^2 - 1}{x}\right)^2 f\left(\frac{1}{x-1}\right) + \left(\frac{x^2 - 1}{x}\right)^2 f\left(\frac{1}{x^2 - 1}\right) = \\ &= \left(\frac{x^2 - 1}{x}\right)^2 \left(\frac{1}{x-1}\right)^2 f(x-1) - \left(\frac{x^2 - 1}{x}\right)^2 \left(\frac{1}{x^2 - 1}\right)^2 f(x^2 - 1) = \\ &= \left(\frac{x+1}{x}\right)^2 f(x-1) - \frac{1}{x^2}f(x^2 - 1). \end{aligned}$$

Setting in (2.4)  $x = 1$  or  $-1$ , we obtain

$$(2.5) \quad f(1) = f(-1) = 0.$$

Hence  $f(u-1) = f(u) - f(1) = f(u)$  for every  $u \in \mathbb{R}$ , and we get

$$f(x) + \frac{1}{x^2}f(x) = \left(\frac{x+1}{x}\right)^2 f(x) - \frac{1}{x^2}f(x^2),$$

$$x^2 f(x) + f(x) = (x+1)^2 f(x) - f(x^2),$$

i.e.,

$$(2.6) \quad f(x^2) = 2xf(x).$$

Again, due to the additivity we have  $f(0) = 0$ . Thus, in view of (2.5), relation (2.6), so far obtained for  $x \neq 0, 1, -1$ , is valid for all  $x \in \mathbb{R}$ . We have by (2.6) for every  $x, y \in \mathbb{R}$

$$f((x+y)^2) = 2(x+y)f(x+y),$$

i.e.,

$$f(x^2) + 2f(xy) + f(y^2) = 2xf(x) + 2xf(y) + 2yf(x) + 2yf(y),$$

and by (2.6)

$$(2.7) \quad 2xf(x) + 2f(xy) + 2yf(y) = 2xf(x) + 2xf(y) + 2yf(x) + 2yf(y).$$

Relation (2.7) yields  $f$  satisfies the Leibniz rule, i.e.,  $f$  is a derivation.  $\square$

**Lemma 2.3.1** *Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  and  $g: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions,  $f \neq 0$ , and let  $P: \mathbb{R} \rightarrow \mathbb{R}$  be a continuous function. If*

$$(2.8) \quad g(x) = P(x)f\left(\frac{1}{x}\right)$$

for all  $x \in \mathbb{R}$ ,  $x \neq 0$ , then

$$(2.9) \quad P(x) = P(1)x^2$$

for all  $x \in \mathbb{R}$ .

**Theorem 2.3.2** *Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  and  $g: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions satisfying the relation*

$$(2.10) \quad g(x) = x^2 f\left(\frac{1}{x}\right)$$

for all  $x \in \mathbb{R}$ ,  $x \neq 0$ . Then the function  $f + g$  is continuous, and the functions  $F, G: \mathbb{R} \rightarrow \mathbb{R}$ :

$$(2.11) \quad F(x) = f(x) - xf(1), \quad G(x) = g(x) - xg(1)$$

are derivations.

**Proof.** We have by (2.10)  $g(1) = f(1)$ , whence by (2.10) and (2.11), for  $x \neq 0$ ,

$$x^2 F\left(\frac{1}{x}\right) = x^2 f\left(\frac{1}{x}\right) - xf(1) = g(x) - xg(1) = G(x)$$

so that

$$(2.12) \quad G(x) = x^2 F\left(\frac{1}{x}\right)$$

for every  $x \neq 0$ . Now,  $F(1) = G(1) = 0$  by (2.11), whence, since  $F$  and  $G$  clearly are additive,  $F(x+1) = F(x) + F(1) = F(x)$  and  $G(x+1) = G(x) + G(1) = G(x)$  for every  $x \in \mathbb{R}$ . Hence and by (2.12) we have for every  $x \neq -1$

$$\begin{aligned} G(x) &= G(x+1) = (x+1)^2 F\left(\frac{1}{x+1}\right) = (x+1)^2 F\left(1 - \frac{x}{x+1}\right) = \\ &= -(x+1)^2 F\left(\frac{x}{x+1}\right) = -(x+1)^2 \left(\frac{x}{x+1}\right)^2 G\left(\frac{x+1}{x}\right) = \\ &= -x^2 G\left(1 + \frac{1}{x}\right) = -x^2 G\left(\frac{1}{x}\right) = -F(x), \end{aligned}$$

i.e.,

$$(2.13) \quad G(x) = -F(x).$$

For  $x = -1$  we have  $G(-1) = -G(1) = 0 = F(1) = -F(-1)$ , so (2.13) holds for  $x = -1$ , too, and thus (2.13) is valid for all  $x \in \mathbb{R}$ . (2.13) yields  $g(x) - xg(1) = -f(x) + xf(1)$ , whence

$$f(x) + g(x) = x(f(1) + g(1)),$$

and consequently  $f + g$  is a continuous function. Further, we get by (2.12) and (2.13)

$$F(x) = -x^2 F\left(\frac{1}{x}\right)$$

for  $x \neq 0$ . By Theorem 2.3.1  $F$  is a derivation, and by Proposition 2.1.1  $G = -F$  also is a derivation.  $\square$

**Theorem 2.3.3** *Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  be an additive function, and let  $P: \mathbb{R} \rightarrow \mathbb{R}$  be a continuous function. If*

$$(2.14) \quad f(x) = P(x) f\left(\frac{1}{x}\right)$$

*for all  $x \in \mathbb{R}$ ,  $x \neq 0$ , then if  $P(1) = -1$ ,  $f$  is a derivation, and if  $P(1) \neq -1$ , then  $f$  is continuous.*

**Proof.** By Lemma 2.3.1

$$(2.15) \quad P(x) = cx^2, \quad x \in \mathbb{R},$$

where  $c = P(1)$ . If  $c = 0$ , then  $f = 0$  by (2.14), and  $f$  is continuous. If  $c \neq 0$ , write  $g(x) = c^{-1}f(x)$ ,  $x \in \mathbb{R}$ . Thus  $g: \mathbb{R} \rightarrow \mathbb{R}$  is an additive function, and (2.14) with (2.15) imply (2.10). By Theorem 2.3.2  $f + g = (1 + c^{-1})f$  is continuous, and hence  $f$  is continuous if  $c \neq -1$ . If  $c = -1$ , then  $P(x) = -x^2$ , and by Theorem 2.3.1  $f$  is a derivation.  $\square$

## 2.4 The cocycle equation

The cocycle functional equation has a long history in connection with many areas of mathematics and its applications, as discussed for example in Jessen–Karpf–Thorup [47], where the authors used the hereunder results to give a simplified proof of Sydler’s theorem on polyhedra.



From our point of view it will be important that the cocycle equation plays a key role in the theory of derivations, as well.

Let  $A$  and  $X$  be commutative groups, then any solution  $F: A^2 \rightarrow X$  of the functional equation

$$F(a + b, c) + F(a, b) = F(a, b + c) + F(b, c) \quad (a, b, c \in A)$$

will be called a *cocycle* on the group  $A$ . Further, this equation will be referred to as the *cocycle equation*. Concerning the solutions of this equation the reader should consult the following works Davison–Ebanks [13], Ebanks [16, 17], Erdős [18]. The results presented here are based on Jessen–Karpf–Thorup [47].

**Theorem 2.4.1** *Let  $A$  and  $X$  be commutative groups, and let  $f: A \rightarrow X$  be an arbitrary function. Then the function  $F: A^2 \rightarrow X$  defined by*

$$(A) \quad F(a, b) = f(a + b) - f(a) - f(b) \quad (a, b \in A),$$

*satisfies equations*

$$(\alpha) \quad F(a, b) = F(b, a) \quad (a, b \in A)$$

*and*

$$(\beta) \quad F(a + b, c) + F(a, b) = F(a, b + c) + F(b, c) \quad (a, b, c \in A),$$

*If  $A$  is free or  $X$  is divisible, the function  $F$  determined by the function  $f$  through equation (A) is the only function which satisfies equations  $(\alpha)$  and  $(\beta)$ .*

Equation  $F \equiv 0$  expresses that the function  $f$  is additive. Thus, for an arbitrary function  $f$ , the function  $F$  may be said to measure how much  $f$  deviates from being additive.

**Theorem 2.4.2** *Let  $A$  be a commutative ring and  $X$  be a module over  $A$ , and let  $f: A \rightarrow X$  be an arbitrary function. Then the functions  $F: A^2 \rightarrow X$  and  $G: A^2 \rightarrow X$  defined by*

$$(A) \quad F(a, b) = f(a + b) - f(a) - f(b),$$

$$(B) \quad G(a, b) = f(ab) - af(b) - bf(a)$$

*satisfy*

$$(\alpha) \quad F(a, b) = F(b, a)$$

$$(\beta) \quad F(a + b, c) + F(a, b) = F(a, b + c) + F(b, c),$$

$$(\gamma) \quad G(a, b) = G(b, a)$$

$$(\delta) \quad cG(a, b) + G(ab, c) = aG(b, c) + G(a, bc),$$

$$(\varepsilon) \quad F(ac, bc) - cF(a, b) = G(a + b, c) - G(a, c) - G(b, c).$$

*Furthermore, if  $A$  has a unity 1 and  $X$  is unitary, then the function  $F$  satisfies the equation*

$$(\zeta) \quad \sum_{i=1}^p F(1, i1) = 0, \quad p = \text{char}A.$$

*If  $A$  is an integral domain and  $X$  is a unitary module over  $A$  which is uniquely  $A$ -divisible, then the pairs of functions  $F, G$  determined by means of a function  $f$  through the equations (A), (B) are the only pairs of functions which satisfy the system  $(\alpha) - (\zeta)$ .*

Notice that the equation ( $\zeta$ ) is void if  $p = 0$ . The equations  $F \equiv 0, G \equiv 0$  express that  $f$  is a derivation. Thus, for an arbitrary  $f$ , the pair of functions  $F, G$  may be said to measure how much  $f$  deviates from being a derivation.

**Lemma 2.4.1** *Let  $A$  be an ordered commutative group and  $X$  be a commutative group, consider further*

$$A_+ = \{a \in A \mid a > 0\}.$$

*Let  $F: A_+^2 \rightarrow X$  be a function which satisfies equations ( $\alpha$ ), ( $\beta$ ) for all  $a, b, c \in A_+$ . Then the functions can be extended to a function  $\widetilde{F}: A^2 \rightarrow X$  which satisfies ( $\alpha$ ) and ( $\beta$ ) for all  $a, b, c \in A$ .*

**Proof.** Define the function  $\widetilde{F}$  as zero when at least one of the elements  $a, b, a + b$  is zero. Otherwise we define  $\widetilde{F}$  according to the following table, where  $+$ , respectively  $-$  stands for  $> 0$  and  $< 0$ .

$a$	$b$	$a + b$	$\widetilde{F}(a, b)$
$+$	$+$	$+$	$F(a, b)$
$+$	$-$	$+$	$-F(a + b, -b)$
$+$	$-$	$-$	$F(-a - b, a)$
$-$	$+$	$+$	$-F(a + b, -a)$
$-$	$+$	$-$	$F(-a - b, b)$
$-$	$-$	$-$	$-F(-a, -b)$

One easily verifies that the function  $\widetilde{F}: A^2 \rightarrow X$  thus defined satisfies the conditions.  $\square$

The verification mentioned in the above proof concerning the definition of the extension  $\widetilde{F}$  requires the consideration of a number of cases. In the paper Jessen–Karpf–Thorup [47], the authors gave an alternative proof, in which there is no need to distinguish between cases.

**Lemma 2.4.2** *Let  $A$  be an ordered commutative ring and  $X$  be a module over  $A$ , and let  $A_+ = \{a \in A \mid a > 0\}$ . Let further  $F, G: A^2 \rightarrow X$  be functions which satisfy equations ( $\alpha$ )–( $\varepsilon$ ) for all  $a, b, c \in A_+$ . Then these functions can be extended to functions  $\widetilde{F}, \widetilde{G}: A^2 \rightarrow X$  which satisfy equations ( $\alpha$ )–( $\varepsilon$ ) for all  $a, b, c \in A$ .*

**Proof.** Define the function  $\widetilde{F}$  as in the proof of Lemma 2.4.1. Further let  $\widetilde{G}(a, b)$  be zero when at least one of the elements  $a, b, a + b$  is zero. Otherwise we define  $\widetilde{G}$  according to the following table, where  $+$ , respectively  $-$  stands for  $> 0$  and  $< 0$ .

$a$	$b$	$\widetilde{G}(a, b)$
$+$	$+$	$G(a, b)$
$+$	$-$	$-G(a, -b)$
$-$	$+$	$-G(-a, b)$
$-$	$-$	$G(-a, -b)$

One easily verifies that the functions  $\widetilde{F}, \widetilde{G}: A^2 \rightarrow X$  thus defined satisfies the conditions.  $\square$

From Theorem 2.4.2 with the choice  $F \equiv 0$  (and interchanging the roles of  $f$  and  $g$ ) the following statement can be obtained immediately.

**Theorem 2.4.3** *Let  $A$  be a commutative ring,  $X$  be a module over  $A$  and  $f: A \rightarrow X$  be a function such that*

$$f(ab) = af(b) + bf(a) \quad (a, b \in A).$$

*Then the function  $F: A \times A \rightarrow X$  defined by (A) fulfills*

$$(\alpha) \quad F(a, b) = F(b, a),$$

*equation  $(\beta)$  is satisfied and also*

$$(\eta) \quad F(ac, bc) = cF(a, b)$$

*holds for any  $a, b, c \in A$ .*

*Furthermore, in case  $A$  is an integral domain and  $X$  is a unitary module over  $A$  which is uniquely  $A$ -divisible, then the function  $F$  defined by the function  $f$  through equation (A) is the only function which satisfies equations  $(\alpha)$ ,  $(\beta)$  and  $(\eta)$ .*

# Chapter 3

## Characterization of derivations through one equation

### 3.1 Preliminaries and former results

The purpose of this chapter is to provide characterization theorems on derivations.

As we saw in the second chapter, the characterization of derivations has an extensive literature, the reader should consult for instance Horinouchi–Kannappan [42], Jurkat [48], Kurepa [55, 56] and also the two monographs Kuczma [54] and Zariski–Samuel [74].

Nevertheless, to the best of the author’s knowledge, all of the characterizations have the following form: additivity and another property imply that the function in question is a derivation. We intend to show that derivations can be characterized by one single functional equation. The results of this chapter are based on the paper Gselmann [29].

More precisely, we would like to examine whether the equations occurring in the definition of derivations are independent in the following sense.

Let  $Q$  be a commutative ring and let  $P$  be a subring of  $Q$ . Let  $\lambda, \mu \in Q \setminus \{0\}$  be arbitrary,  $f: P \rightarrow Q$  be a function and consider the equation

$$\lambda [f(x + y) - f(x) - f(y)] + \mu [f(xy) - xf(y) - yf(x)] = 0. \quad (x, y \in P)$$

Clearly, if the function  $f$  is a derivation, then this equation holds. In the next section we will investigate the opposite direction, and it will be proved that, under some assumptions on the rings  $P$  and  $Q$ , derivations can be characterized through the above equation. This result will be proved as a consequence of the main theorem that will be devoted to the equation

$$f(x + y) - f(x) - f(y) = g(xy) - xg(y) - yg(x), \quad (x, y \in P)$$

where  $f, g: P \rightarrow Q$  are unknown functions.

We remark that similar investigations were made by Dhombres [15], Ger [24, 25] and also by Ger–Reich [26] concerning ring homomorphisms. For instance, in Ger [24] the following theorem was proved.

**Theorem 3.1.1** *Let  $X$  and  $Y$  are two rings, and assume that for all  $x \in X$  there exists  $e_x \in X$  such that  $xe_x = x$ , suppose further that  $Y$  has no elements of order 2 and does not admit zero divisors. If  $f$  is a solution of the equation*

$$f(x + y) + f(xy) = f(x) + f(y) + f(x)f(y) \quad (x, y \in X)$$

*such that  $f(0) = 0$ , then either  $3f$  is even and  $3f(2x) = 0$  for all  $x \in X$ , or  $f$  yields a homomorphism between  $X$  and  $Y$ .*

During the proof of the main result the celebrated *cocycle equation* will play a key role. About this equation one can read e.g. in Aczél [1], Davison–Ebanks [13], Ebanks [17], Erdős [18], Hosszú [43] and also in Jessen–Karpf–Thorup [47]. In the next section we will however utilize only Theorem 2.4.2.

## 3.2 Characterization of derivations through one equation

Our main result in this direction is contained in the following.

**Theorem 3.2.1** *Let  $\mathbb{F}$  be a field,  $X$  be a vector space over  $\mathbb{F}$  and  $f, g: \mathbb{F} \rightarrow X$  be functions such that*

$$(E) \quad f(x+y) - f(x) - f(y) = g(xy) - xg(y) - yg(x)$$

*holds for all  $x, y \in \mathbb{F}$ . Then, and only then, there exist additive functions  $\alpha, \beta: \mathbb{F} \rightarrow X$  and a function  $\varphi: \mathbb{F} \rightarrow X$  with the property*

$$\varphi(xy) = x\varphi(y) + y\varphi(x) \quad (x, y \in \mathbb{F}),$$

*such that*

$$f(x) = \beta(x) + \frac{1}{2}\alpha(x^2) - x\alpha(x) \quad (x, y \in \mathbb{F})$$

*and*

$$g(x) = \varphi(x) + \alpha(x) \quad (x, y \in \mathbb{F})$$

*are satisfied.*

**Proof.** Define the functions  $\mathcal{C}_f, \mathcal{D}_f, \mathcal{C}_g$  and  $\mathcal{D}_g$  on  $\mathbb{F} \times \mathbb{F}$  by

$$\begin{aligned} \mathcal{C}_f(x, y) &= f(x+y) - f(x) - f(y) \\ \mathcal{D}_f(x, y) &= f(xy) - xf(y) - yf(x) \\ \mathcal{C}_g(x, y) &= g(x+y) - g(x) - g(y) \\ \mathcal{D}_g(x, y) &= g(xy) - xg(y) - yg(x), \end{aligned}$$

respectively. In view of Theorem 2.4.2, we immediately get that the pairs  $(\mathcal{C}_f, \mathcal{D}_f)$  and  $(\mathcal{C}_g, \mathcal{D}_g)$  fulfill the system of equations (α)–(ε). Furthermore, equation (E) yields that

$$(E^*) \quad \mathcal{C}_f(x, y) = \mathcal{D}_g(x, y)$$

for all  $x, y \in \mathbb{F}$ . Due to equation (ε),

$$(3.1) \quad \mathcal{C}_g(xz, yz) - z\mathcal{C}_g(x, y) = \mathcal{D}_g(x+y, z) - \mathcal{D}_g(x, z) - \mathcal{D}_g(y, z)$$

holds for all  $x, y, z \in \mathbb{F}$ . Interchanging the role of  $x$  and  $z$  in the previous equation, we obtain that

$$(3.2) \quad \mathcal{C}_g(xz, xy) - x\mathcal{C}_g(z, y) = \mathcal{D}_g(y+z, x) - \mathcal{D}_g(z, x) - \mathcal{D}_g(y, x)$$

for any  $x, y, z \in \mathbb{F}$ . Let us subtract equation (3.2) from (3.1), to obtain

$$\begin{aligned} \mathcal{C}_g(xz, yz) - z\mathcal{C}_g(x, y) - \mathcal{C}_g(xz, xy) + x\mathcal{C}_g(z, y) \\ = \mathcal{D}_g(x+y, z) - \mathcal{D}_g(x, z) - \mathcal{D}_g(y, z) - \mathcal{D}_g(z+y, x) + \mathcal{D}_g(z, x) + \mathcal{D}_g(y, x). \end{aligned}$$

Because of  $(\mathcal{E}^*)$ , the function  $\mathcal{D}_g$  can be replaced by  $\mathcal{C}_f$ . This implies however that

$$\begin{aligned} \mathcal{C}_g(xz, yz) - z\mathcal{C}_g(x, y) - \mathcal{C}_g(xz, xy) + x\mathcal{C}_g(z, y) \\ = \mathcal{C}_f(x + y, z) + \mathcal{C}_f(x, y) - \mathcal{C}_f(x, y + z) - \mathcal{C}_f(y, z) = 0, \end{aligned}$$

for all  $x, y, z \in \mathbb{F}$ , where we used that the function  $\mathcal{C}_f$  fulfills  $(\alpha)$  and  $(\beta)$ . This equation with  $z = 1$  yields that

$$\mathcal{C}_g(x, xy) = x\mathcal{C}_g(1, y),$$

or if we replace  $y$  by  $\frac{y}{x}$ , ( $x \neq 0$ )

$$\mathcal{C}_g(x, y) = x\mathcal{C}_g\left(1, \frac{y}{x}\right). \quad (x, y \in \mathbb{F}, x \neq 0)$$

We will show that from this identity the homogeneity of  $\mathcal{C}_g$  follows. Indeed, let  $t, x, y \in \mathbb{F}$ ,  $t, x \neq 0$  be arbitrary, then

$$\mathcal{C}_g(tx, ty) = tx\mathcal{C}_g\left(1, \frac{ty}{tx}\right) = tx\mathcal{C}_g\left(1, \frac{y}{x}\right) = t\mathcal{C}_g(x, y).$$

If  $x = 0$ , we get from equation  $(\mathcal{E}^*)$  that  $\mathcal{C}_g(0, 0) = 0$ , thus for arbitrary  $t \in \mathbb{F}$ ,

$$\mathcal{C}_g(t0, t0) = 0 = t\mathcal{C}_g(0, 0).$$

Furthermore, in case  $t = 0$ , then for any  $x, y \in \mathbb{F}$

$$\mathcal{C}_g(tx, ty) = \mathcal{C}_g(0, 0) = 0 = t\mathcal{C}_g(x, y).$$

This means that the function  $\mathcal{C}_g$  is homogeneous and fulfills equations  $(\alpha)$  and  $(\beta)$ . In view of Theorem 2.4.3, there exists a function  $\varphi: \mathbb{F} \rightarrow X$  such that

$$\varphi(xy) = x\varphi(y) + y\varphi(x) \quad (x, y \in \mathbb{F})$$

and

$$\mathcal{C}_g(x, y) = \varphi(xy) - x\varphi(y) - y\varphi(x) \quad (x, y \in \mathbb{F})$$

hold. Due to the definition of the function  $\mathcal{C}_g$ , this yields that

$$g(x) = \varphi(x) + \alpha(x) \quad (x \in \mathbb{F}),$$

where the function  $\varphi$  fulfills the above identity and  $\alpha: \mathbb{F} \rightarrow X$  is additive. Writing this representation of the function  $g$  into equation  $(\mathcal{E})$ , we have that

$$(3.3) \quad f(x + y) - f(x) - f(y) = \alpha(xy) - x\alpha(y) - y\alpha(x) \quad (x, y \in \mathbb{F}).$$

Since the function  $\alpha$  is additive, the two place function

$$\mathcal{D}_\alpha(x, y) = \alpha(xy) - x\alpha(y) - y\alpha(x) \quad (x, y \in \mathbb{F})$$

is a symmetric, biadditive function. Therefore,  $\mathcal{D}_\alpha$  can be written as the Cauchy difference of its trace, that is

$$\begin{aligned} \mathcal{D}_\alpha(x, y) = \frac{1}{2}\alpha((x + y)^2) - (x + y)\alpha(x + y) \\ - \left(\frac{1}{2}\alpha(x^2) - x\alpha(x)\right) - \left(\frac{1}{2}\alpha(y^2) - y\alpha(y)\right) \quad (x, y \in \mathbb{F}). \end{aligned}$$

In view of equation (3.3), this yields that the function

$$x \mapsto f(x) - \left( \frac{1}{2} \alpha(x^2) - x\alpha(x) \right) \quad (x \in \mathbb{F})$$

is additive. Thus there exists an additive function  $\beta: \mathbb{F} \rightarrow X$  such that

$$f(x) = \beta(x) + \frac{1}{2} \alpha(x^2) - x\alpha(x) \quad (x \in \mathbb{F}).$$

□

According to Lemma 2.4.2, with the aid of the previous result, the following corollary can immediately be obtained.

**Corollary 3.2.1** *Let  $\mathbb{F}$  be an ordered field,  $X$  be a vector space over  $\mathbb{F}$ ,  $\mathbb{F}_+ = \{x \in \mathbb{F} | x > 0\}$  and  $f, g: \mathbb{F}_+ \rightarrow X$  be functions such that*

$$f(x+y) - f(x) - f(y) = g(xy) - xg(y) - yg(x)$$

*holds for all  $x, y \in \mathbb{F}_+$ . Then the functions  $f$  and  $g$  can be extended to functions  $\tilde{f}, \tilde{g}: \mathbb{F} \rightarrow X$  such that*

$$\tilde{f}(x) = \beta(x) + \frac{1}{2} \alpha(x^2) - x\alpha(x) \quad (x, y \in \mathbb{F})$$

*and*

$$\tilde{g}(x) = \varphi(x) + \alpha(x), \quad (x, y \in \mathbb{F})$$

*where  $\alpha, \beta: \mathbb{F} \rightarrow X$  are additive function and  $\varphi: \mathbb{F} \rightarrow X$  fulfills*

$$\varphi(xy) = x\varphi(y) + y\varphi(x) \quad (x, y \in \mathbb{F}).$$

From our main result of this section, with the choice  $g(x) = -\frac{\mu}{\lambda} f(x)$  the following corollary can be derived easily.

**Corollary 3.2.2** *Let  $\mathbb{F}$  be a field and  $X$  be a vector space over  $\mathbb{F}$ ,  $\lambda, \mu \in \mathbb{F} \setminus \{0\}$  be arbitrarily fixed. Then the function  $f: \mathbb{F} \rightarrow X$  is a derivation if and only if*

$$\lambda [f(x+y) - f(x) - f(y)] + \mu [f(xy) - xf(y) - yf(x)] = 0$$

*holds for all  $x, y \in \mathbb{F}$ .*

Let us observe that Theorem 3.2.1 heavily uses that the functions involved map a field into a vector space. At the same time the problem can also be formulated in a more general setting, e.g., in (commutative) rings. Thus, we can ask the following.

**Open Problem 1** *Let  $A$  be a ring and  $X$  be a module over  $A$ . Assume that for the functions  $f, g: A \rightarrow X$ , functional equation*

$$f(x+y) - f(x) - f(y) = g(xy) - xg(y) - yg(x)$$

*is fulfilled for any  $x, y \in A$ . Prove or disprove that the same conclusion holds as in Theorem 3.2.1.*

Our results can be restated with the aid of the notion of alien functional equations. This concept was introduced and developed by J. Dhombres in the paper [15]. However, the interested reader should also consult Ger [24, 25] and Ger–Reich [26].

Let  $X$  and  $Y$  be nonvoid sets and  $E_1(f) = 0$  and  $E_2(f) = 0$  be two functional equations for the function  $f: X \rightarrow Y$ . We say that equations  $E_1$  and  $E_2$  are *alien*, if any solution  $f: X \rightarrow Y$  of the functional equation

$$E_1(f) + E_2(f) = 0$$

also solves the system

$$\begin{aligned} E_1(f) &= 0 \\ E_2(f) &= 0. \end{aligned}$$

Furthermore, equations  $E_1$  and  $E_2$  are *strongly alien*, if any pair  $f, g: X \rightarrow Y$  of functions that solves

$$E_1(f) + E_1(g) = 0$$

also yields a solution for

$$\begin{aligned} E_1(f) &= 0 \\ E_2(g) &= 0. \end{aligned}$$

According to the above notions, Theorem 3.2.1 says that the (additive) Cauchy equation, i.e.,

$$f(x + y) = f(x) + f(y) \quad (x, y \in \mathbb{F})$$

and the Leibniz rule, that is,

$$f(xy) = xf(y) + f(x)y \quad (x, y \in \mathbb{F}).$$

are *alien*, but not *strongly alien*.

In a recent paper [60] Gy. Maksa and M. Sablik investigated whether the exponential Cauchy equation and the Hosszú equation are (strongly) alien. In the abovementioned paper they proved the following.

**Theorem 3.2.2** *Suppose that the functions  $f, g: \mathbb{R} \rightarrow \mathbb{R}$  satisfy functional equation*

$$g(x)g(y) - g(xy) = f(x + y - xy) - f(x) - f(y) + f(xy) \quad (x, y \in \mathbb{R}).$$

*Assuming that the function  $f$  is continuous, the function  $g$  is a solution of the exponential Cauchy equation and*

$$f(x) = \alpha x + \beta \quad (x \in \mathbb{R})$$

*is fulfilled with a certain constants  $\alpha, \beta \in \mathbb{R}$ .*

In view of the above notions, this results expresses that (under some regularity assumptions) the exponential Cauchy equation and the Hosszú equation are strongly alien.

Let  $f: \mathbb{R} \rightarrow \mathbb{R}$  be a derivation. Then  $f$  clearly solves the system of functional equations

$$\begin{aligned} f(x + y - xy) &= f(x) + f(y) - f(xy) \\ f(xy) &= xf(y) + f(x)y \end{aligned} \quad (x, y \in \mathbb{R})$$

as well as the single equation

$$f(x + y - xy) - f(x) - f(y) + f(xy) = f(xy) - xf(y) - f(x)y \quad (x, y \in \mathbb{R})$$

Our second open problem is about the converse.



**Open Problem 2** Assume that the function  $f: \mathbb{R} \rightarrow \mathbb{R}$  fulfills functional equation

$$f(x + y - xy) - f(x) - f(y) + f(xy) = f(xy) - xf(y) - f(x)y$$

for all  $x, y \in \mathbb{R}$ .

- (i) Prove or disprove that the function  $f$  is a real derivation.
- (ii) What can be said if we consider the problem not on the set of the real numbers, but on rings or on fields?

To formulate our last open problem in this section, let us observe that if  $f: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation, then  $f$  yields a solution for the system of functional equations

$$\begin{aligned} f\left(\frac{x+y}{2}\right) &= f(x) + f(y) \\ f(xy) &= xf(y) + f(x)y \end{aligned} \quad (x, y \in \mathbb{R})$$

as well as the single equation

$$f\left(\frac{x+y}{2}\right) - f(x) - f(y) = f(xy) - xf(y) - f(x)y \quad (x, y \in \mathbb{R}).$$

**Open Problem 3** Assume that the function  $f: \mathbb{R} \rightarrow \mathbb{R}$  fulfills functional equation

$$f\left(\frac{x+y}{2}\right) - f(x) - f(y) = f(xy) - xf(y) - f(x)y$$

for all  $x, y \in \mathbb{R}$ .

- (i) Prove or disprove that the function  $f$  is a real derivation.
- (ii) What can be said if we consider the problem not on the set of the real numbers, but on rings or on fields?

# Chapter 4

## Additive solvability and linear independence of the solutions of a system of functional equations

### 4.1 Introduction

In this chapter we investigate two problems concerning derivations. On one hand, the additive solvability of the system of functional equations

$$d_k(xy) = \sum_{i=0}^k \Gamma(i, k-i) d_i(x) d_{k-i}(y) \quad (x, y \in \mathbb{R}, k \in \{0, \dots, n\})$$

is studied, where  $\Delta_n := \{(i, j) \in \mathbb{Z} \times \mathbb{Z} \mid 0 \leq i, j \text{ and } i + j \leq n\}$  and  $\Gamma: \Delta_n \rightarrow \mathbb{R}$  is a symmetric function such that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$ .

On the other hand, the linear dependence and independence of the additive solutions  $d_0, d_1, \dots, d_n: \mathbb{R} \rightarrow \mathbb{R}$  of the above system of equations is characterized. As a consequence of the main result, for any nonzero real derivation  $d: \mathbb{R} \rightarrow \mathbb{R}$ , the iterates  $d^0, d^1, \dots, d^n$  of  $d$  are shown to be linearly independent, and the graph of the mapping  $x \mapsto (x, d^1(x), \dots, d^n(x))$  to be dense in  $\mathbb{R}^{n+1}$ .

Given a real derivation  $d: \mathbb{R} \rightarrow \mathbb{R}$ , one can prove by induction that the iterates  $d^0 := id$ ,  $d^1 := d$ ,  $\dots$ ,  $d^n := d \circ d^{n-1}$  of  $d$  satisfy the following higher-order Leibniz rule

$$d^k(xy) = \sum_{i=0}^k \binom{k}{i} d^i(x) d^{k-i}(y) \quad (x, y \in \mathbb{R}, k \in \{1, \dots, n\}).$$

Motivated by this property, Heyneman–Sweedler [41] introduced the notion of  $n$ th-order derivation (in the context of functions mapping rings to modules, however, we will restrict ourselves only to real functions).

**Definition 4.1.1** Given  $n \in \mathbb{N}$ , a sequence of additive functions  $d_0, d_1, \dots, d_n: \mathbb{R} \rightarrow \mathbb{R}$  is termed a derivation of order  $n$ , if  $d_0 = id$  and, for any  $k \in \{1, \dots, n\}$ ,

$$(4.1) \quad d_k(xy) = \sum_{i=0}^k \binom{k}{i} d_i(x) d_{k-i}(y) \quad (x, y \in \mathbb{R})$$

is fulfilled.

Clearly, a pair  $(id, d)$  is a first-order derivation if and only if  $d$  is a derivation. More generally, if  $d: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation, then the sequence  $(d^0, d^1, \dots, d^n)$  is a derivation of order  $n$ . However, if  $\tilde{d}: \mathbb{R} \rightarrow \mathbb{R}$  is a nontrivial derivation and  $n \geq 2$ , then  $(d^0, d^1, \dots, d^{n-1}, d^n + \tilde{d})$  is also an  $n$ th-order derivation where the last element is not the  $n$ th iterate of the derivation  $d$ .

Firstly we will study the additive solvability of the following system of functional equations

$$(4.2) \quad d_k(xy) = \sum_{i=0}^k \Gamma(i, k-i) d_i(x) d_{k-i}(y) \quad (x, y \in \mathbb{R}, k \in \{0, \dots, n\}),$$

where

$$(4.3) \quad \Delta_n := \{(i, j) \in \mathbb{Z} \times \mathbb{Z} \mid 0 \leq i, j \text{ and } i + j \leq n\},$$

and  $\Gamma: \Delta_n \rightarrow \mathbb{R}$  is a symmetric function such that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$ . After that we shall characterize the linear dependence and independence of the additive solutions  $d_0, d_1, \dots, d_n: \mathbb{R} \rightarrow \mathbb{R}$  of (4.2).

## 4.2 On the additive solvability of the system of functional equations (4.2)

As consequence of Theorem 2.4.1, we can characterize those two-variable functions that are identical to the Leibniz difference of an additive function.

**Theorem 4.2.1** *Let  $X$  be a real linear space and  $D: \mathbb{R}^2 \rightarrow X$ . Then there exists an additive function  $f: \mathbb{R} \rightarrow X$  fulfilling functional equation*

$$(4.4) \quad D(x, y) = f(xy) - xf(y) - yf(x) \quad (x, y \in \mathbb{R})$$

*if and only if  $D$  satisfies*

$$(4.5) \quad \begin{aligned} D(x, y) &= D(y, x) & (x, y \in \mathbb{R}), \\ D(xy, z) + zD(x, y) &= D(x, yz) + xD(y, z) & (x, y, z \in \mathbb{R}), \\ D(x + y, z) &= D(x, z) + D(y, z) & (x, y, z \in \mathbb{R}). \end{aligned}$$

Our first main result offers a sufficient condition on the recursive additive solvability of the functional equation (4.2). We deduce this result by using Theorem 4.2.1, however, we note that another proof could be elaborated applying the results of Gselmann [29].

**Theorem 4.2.2** *Let  $n \geq 2$  and  $\Gamma: \Delta_n \rightarrow \mathbb{R}$  be a symmetric function such that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$  and*

$$(4.6) \quad \Gamma(i + j, k)\Gamma(i, j) = \Gamma(i, j + k)\Gamma(j, k) \quad (0 \leq i, j, k \text{ and } i + j + k \leq n).$$

*Let  $d_0 = id$  and let  $d_1, \dots, d_{n-1}: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions such that (4.2) holds for  $k \in \{1, \dots, n-1\}$ . Then there exists an additive function  $d_n: \mathbb{R} \rightarrow \mathbb{R}$  such that (4.2) is also valid for  $k = n$ .*

**Proof.** Using  $\Gamma(0, n) = \Gamma(n, 0) = 1$ , the functional equation for  $d_n: \mathbb{R} \rightarrow \mathbb{R}$  can be rewritten as

$$(4.7) \quad d_n(xy) - xd_n(y) - yd_n(x) = D_n(x, y) := \sum_{i=1}^{n-1} \Gamma(i, n-i)d_i(x)d_{n-i}(y) \quad (x, y \in \mathbb{R}).$$

Thus, in view of Theorem 4.2.1, in order that there exist an additive function  $d_n$  such that (4.7) hold, it is necessary and sufficient that  $D = D_n$  satisfy the conditions in (4.5). The symmetry of  $\Gamma$  implies the symmetry, the additivity of  $d_1, \dots, d_{n-1}$  results the biadditivity of  $D_n$ . Thus, it suffices to prove that  $D = D_n$  also satisfies the second identity in (4.5). This is equivalent to showing that, for all fixed  $y \in \mathbb{R}$ , the mapping  $(x, z) \mapsto D_n(xy, z) + zD_n(x, y)$  is symmetric. Using equations (4.2) for  $k \in \{1, \dots, n-1\}$ , we obtain

$$(4.8) \quad \begin{aligned} D_n(xy, z) + zD_n(x, y) &= \sum_{k=1}^{n-1} \Gamma(k, n-k)d_k(xy)d_{n-k}(z) + z \sum_{i=1}^{n-1} \Gamma(i, n-i)d_i(x)d_{n-i}(y) \\ &= \sum_{k=1}^{n-1} \Gamma(k, n-k) \left( \sum_{i=0}^k \Gamma(i, k-i)d_i(x)d_{k-i}(y) \right) d_{n-k}(z) \\ &\quad + z \sum_{i=1}^{n-1} \Gamma(i, n-i)d_i(x)d_{n-i}(y) \\ &= \sum_{k=0}^n \sum_{i=0}^k \Gamma(k, n-k)\Gamma(i, k-i)d_i(x)d_{k-i}(y)d_{n-k}(z) \\ &\quad - xyd_n(z) - xzd_n(y) - yzd_n(x) \\ &= \sum_{\alpha, \beta, \gamma \geq 0, \alpha+\beta+\gamma=n} \Gamma(\alpha+\beta, \gamma)\Gamma(\alpha, \beta)d_\alpha(x)d_\beta(y)d_\gamma(z) \\ &\quad - xyd_n(z) - xzd_n(y) - yzd_n(x). \end{aligned}$$

The sum of the last three terms in the above expression is symmetric in  $(x, z)$ . The symmetry of the first summand is the consequence of the symmetry of  $(\alpha, \gamma) \mapsto \Gamma(\alpha+\beta, \gamma)\Gamma(\alpha, \beta)$  which follows from property (4.6).  $\square$

**Remark 4.2.1** Let  $n \geq 2$  and  $\Gamma: \Delta_n \rightarrow \mathbb{R}$  be a symmetric function such that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$ . Then condition (4.6) obviously holds if  $i \cdot j \cdot k = 0$  or if  $i = k$ , therefore (4.6) is equivalent to the following condition

$$(4.9) \quad \Gamma(i+j, k)\Gamma(i, j) = \Gamma(i, j+k)\Gamma(j, k) \quad (1 \leq i, j, k, i \neq k \text{ and } i+j+k \leq n),$$

which is non-trivial only for  $n \geq 4$ .

On the other hand, as we have seen it in the proof of Theorem 4.2.2, in order that there exist an additive function  $d_n$  such that (4.7) hold, it is not only sufficient but also necessary that  $D = D_n$  satisfy the second identity in (4.5), which, using formula (4.8), the symmetry and the marginal values of  $\Gamma$ , is equivalent to the condition

$$(4.10) \quad \sum_{\alpha, \beta, \gamma \geq 1, \alpha \neq \gamma, \alpha+\beta+\gamma=n} (\Gamma(\alpha+\beta, \gamma)\Gamma(\alpha, \beta) - \Gamma(\gamma+\beta, \alpha)\Gamma(\gamma, \beta))d_\alpha(x)d_\beta(y)d_\gamma(z) = 0.$$

If  $n \in \{0, 1, 2, 3\}$ , then the above condition holds automatically. For  $n = 4$ , the above condition can be written as

$$(4.11) \quad (\Gamma(2, 2)\Gamma(1, 1) - \Gamma(1, 3)\Gamma(1, 2))d_1(y)(d_1(x)d_2(z) - d_1(z)d_2(x)) = 0.$$

Provided that  $d_1$  and  $d_2$  are linearly independent, (4.11) implies that

$$\Gamma(2, 2)\Gamma(1, 1) = \Gamma(1, 3)\Gamma(1, 2),$$

which proves that (4.9) is necessary for  $n = 4$ . An analogous and careful computation yields that in the case  $n = 5$ , provided that  $d_1$  and  $d_2$  as well as  $d_1$  and  $d_3$  are linearly independent then  $\Gamma(3, 2)\Gamma(1, 2) = \Gamma(1, 4)\Gamma(2, 2)$  and  $\Gamma(2, 3)\Gamma(1, 1) = \Gamma(1, 4)\Gamma(1, 3)$  are necessary conditions which shows that (4.9) is necessary also for  $n = 5$ . In the case  $n \geq 6$ , we conjecture that linear independence of the functions  $d_1, \dots, d_{n-2}$  is sufficient to guarantee the necessity of (4.9).

In what follows, we describe the nowhere zero solutions of (4.6).

**Theorem 4.2.3** *Let  $n \geq 2$  and  $\Gamma: \Delta_n \rightarrow \mathbb{R} \setminus \{0\}$  be a symmetric function so that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$ . Then  $\Gamma$  satisfies the functional equation (4.6) if and only if there exists a function  $\gamma: \{0, 1, \dots, n\} \rightarrow \mathbb{R} \setminus \{0\}$  such that*

$$(4.12) \quad \Gamma(i, j) = \frac{\gamma(i+j)}{\gamma(i)\gamma(j)} \quad ((i, j) \in \Delta_n).$$

**Proof.** Define the function  $\gamma: \{0, 1, \dots, n\} \rightarrow \mathbb{R} \setminus \{0\}$  through

$$\gamma(k) = \prod_{\ell=1}^{k-1} \Gamma(\ell, 1) \quad (k \in \{0, 1, \dots, n\}).$$

The empty product being equal to 1, we have that  $\gamma(0) = \gamma(1) = 1$ .

To complete the proof, we have to show that, for any  $(i, j) \in \Delta_n$ ,

$$\Gamma(i, j) = \frac{\gamma(i+j)}{\gamma(i)\gamma(j)}.$$

This equivalent to proving that

$$(4.13) \quad \Gamma(i, j) \prod_{\ell=1}^{i-1} \Gamma(\ell, 1) = \prod_{\ell=j}^{i+j-1} \Gamma(\ell, 1) \quad ((i, j) \in \Delta_n).$$

This identity trivially holds for  $i = 0, i = 1$  and for any  $j \in \{0, \dots, n-i\}$ . Let  $j \in \{0, \dots, n-2\}$  be fixed. We prove (4.13) by induction on  $i \in \{1, \dots, n-j\}$ . Assume that (4.13) holds for  $i \in \{1, \dots, n-j-1\}$ . Then,

$$(4.14) \quad \begin{aligned} \Gamma(i+1, j) \prod_{\ell=1}^i \Gamma(\ell, 1) &= \frac{\Gamma(i+1, j)\Gamma(i, 1)}{\Gamma(i, j)} \left( \Gamma(i, j) \prod_{\ell=1}^{i-1} \Gamma(\ell, 1) \right) \\ &= \frac{\Gamma(i+1, j)\Gamma(i, 1)}{\Gamma(i, j)} \prod_{\ell=j}^{i+j-1} \Gamma(\ell, 1) = \frac{\Gamma(i+1, j)\Gamma(i, 1)}{\Gamma(i, j)\Gamma(i+j, 1)} \prod_{\ell=j}^{i+j} \Gamma(\ell, 1). \end{aligned}$$

Using (4.6), it follows that  $\Gamma(i+1, j)\Gamma(i, 1) = \Gamma(i, j)\Gamma(i+j, 1)$ , hence (4.14) yields (4.13) for  $i+1$  instead of  $i$ .

Conversely, suppose that there exists a function  $\gamma: \{0, 1, \dots, n\} \rightarrow \mathbb{R} \setminus \{0\}$  such that

$$\Gamma(i, j) = \frac{\gamma(i+j)}{\gamma(i)\gamma(j)} \quad ((i, j) \in \Delta_n).$$

Then, for any  $i, j, k \geq 0$  with  $i+j+k \leq n$ , we have

$$\Gamma(i+j, k)\Gamma(i, j) = \frac{\gamma(i+j+k)}{\gamma(i+j)\gamma(k)} \cdot \frac{\gamma(i+j)}{\gamma(i)\gamma(j)} = \frac{\gamma(i+j+k)}{\gamma(i)\gamma(j+k)} \cdot \frac{\gamma(j+k)}{\gamma(j)\gamma(k)} = \Gamma(i, j+k)\Gamma(j, k),$$

which completes the proof.  $\square$

When  $\Gamma$  is of the form (4.12), then Theorem 4.2.2 reduces to the following statement.

**Corollary 4.2.1** *Let  $n \geq 2$  and  $\gamma: \{0, 1, \dots, n\} \rightarrow \mathbb{R} \setminus \{0\}$  with  $\gamma(0) = 1$ . Let  $d_0 = \text{id}$  and let  $d_1, \dots, d_{n-1}: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions such that*

$$(4.15) \quad d_k(xy) = \sum_{i=0}^k \frac{\gamma(k)}{\gamma(i)\gamma(k-i)} d_i(x) d_{k-i}(y) \quad (x, y \in \mathbb{R})$$

*holds for  $k \in \{1, \dots, n-1\}$ . Then there exists an additive function  $d_n: \mathbb{R} \rightarrow \mathbb{R}$  such that (4.15) is also valid for  $k = n$ .*

We note that if in the above corollary  $\gamma(k) = k!$ , then (4.15) is equivalent to (4.1), that is  $\text{id}, d_1, \dots, d_n$  is a derivation of order  $n$ .

### 4.3 A characterization of the linear dependence of additive functions

**Theorem 4.3.1** *Let  $X$  be a Hausdorff locally convex linear space and let  $a: \mathbb{R} \rightarrow X$  be an additive function. Then the following statements are equivalent:*

- (i) *there exists a nonzero continuous linear functional  $\varphi \in X^*$  such that  $\varphi \circ a = 0$ ;*
- (ii) *there exists an upper semicontinuous function  $\Phi: X \rightarrow \mathbb{R}$  such that  $\Phi \not\equiv 0$  and  $\Phi \circ a \geq 0$ ;*
- (iii) *the range of  $a$  is not dense in  $X$ , i.e.,  $\overline{a(\mathbb{R})} \neq X$ .*

**Proof.** The implication (i) $\Rightarrow$ (ii) is obvious, because  $\Phi$  can be chosen as  $\varphi$ .

To prove (ii) $\Rightarrow$ (iii), assume that there exists an upper semicontinuous function  $\Phi: X \rightarrow \mathbb{R}$  such that  $\Phi \not\equiv 0$  and  $\Phi \circ a \geq 0$ . Then  $U := \{x \in X \mid \Phi(x) < 0\}$  is a nonempty and open set. The inequality  $\Phi \circ a \geq 0$  implies that  $U \cap a(\mathbb{R}) = \emptyset$ , which proves that the range of  $a$  cannot be dense in  $X$ .

Finally, suppose that  $\overline{a(\mathbb{R})} \neq X$ . By the additivity of  $a$ , the set  $a(\mathbb{R})$  is closed under addition and multiplication by rational numbers. Therefore, the closure of  $a(\mathbb{R})$  is a proper closed linear subspace of  $X$ . Then, by the Hahn–Banach theorem, there exists a nonzero continuous linear functional  $\varphi \in X^*$  which vanishes on  $a(\mathbb{R})$ , i.e.,  $\varphi \circ a = 0$  is satisfied.  $\square$

By taking  $X = \mathbb{R}^n$ , the above theorem immediately simplifies to the following consequence which characterizes the linear dependence of finitely many additive functions.

**Corollary 4.3.1** *Let  $n \in \mathbb{N}$  and  $a_1, \dots, a_n: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions. Then the following statements are equivalent:*

- (i) *the additive functions  $a_1, \dots, a_n$  are linearly dependent, i.e., there exist  $c_1, \dots, c_n \in \mathbb{R}$  such that  $c_1^2 + \dots + c_n^2 > 0$  and  $c_1 a_1 + \dots + c_n a_n = 0$ ;*
- (ii) *there exists an upper semicontinuous function  $\Phi: \mathbb{R}^n \rightarrow \mathbb{R}$  such that  $\Phi \not\equiv 0$  and*

$$\Phi(a_1(x), \dots, a_n(x)) \geq 0 \quad (x \in \mathbb{R});$$
- (iii) *the set  $\{(a_1(x), \dots, a_n(x)) \mid x \in \mathbb{R}\}$  is not dense in  $\mathbb{R}^n$ .*

In the particular case of this corollary, namely when  $\Phi$  is an indefinite quadratic form, the equivalence of statements (i) and (ii) is the main result of the paper [53] by Kocsis. A former result in this direction is due to Maksa and Rätz [59]: If two additive functions  $a, b: \mathbb{R} \rightarrow \mathbb{R}$  satisfy  $a(x)b(x) \geq 0$  then  $a$  and  $b$  are linearly dependent.

## 4.4 Linear independence of iterates of nonzero derivations

In this section we apply Corollary 4.3.1 to the particular case when the additive functions are iterates of a real derivation. However, firstly we prove the following for higher order derivations.

**Theorem 4.4.1** *Let  $n \in \mathbb{N}$ , let  $\Gamma: \Delta_n \rightarrow \mathbb{R}$  be a symmetric function such that  $\Gamma(i, j) = 1$  whenever  $i \cdot j = 0$ , (4.6) is satisfied and, for all  $k \in \{2, \dots, n\}$  there exists  $i \in \{1, \dots, k-1\}$  such that  $\Gamma(i, k-i) \neq 0$ . Assume that  $d_0 = \text{id}$  and  $d_1, \dots, d_n: \mathbb{R} \rightarrow X$  are additive functions satisfying (4.2) for all  $k \in \{1, \dots, n\}$ . Then the following statements are equivalent:*

(i) *there exist  $c_0, c_1, \dots, c_n \in \mathbb{R}$  such that  $c_0^2 + c_1^2 + \dots + c_n^2 > 0$  and*

$$(4.16) \quad c_0x + c_1d_1(x) + \dots + c_nd_n(x) = 0 \quad (x \in \mathbb{R});$$

(ii) *there exists an upper semicontinuous function  $\Phi: \mathbb{R}^{n+1} \rightarrow \mathbb{R}$  such that  $\Phi \not\equiv 0$  and*

$$\Phi(x, d_1(x), \dots, d_n(x)) \geq 0 \quad (x \in \mathbb{R});$$

(iii) *the set  $\{(x, d_1(x), \dots, d_n(x)) \mid x \in \mathbb{R}\}$  is not dense in  $\mathbb{R}^{n+1}$ ;*

(iv)  $d_1 = 0$ .

**Proof.** Applying Corollary 4.3.1 to the additive functions  $a_i(x) = d_i(x)$  ( $i \in \{0, 1, \dots, n\}$ ), it follows that (i), (ii) and (iii) are equivalent. The implication (iv) $\Rightarrow$ (i) is obvious since if  $d_1 = 0$ , then (i) holds with  $c_1 = 1$  and  $c_0 = c_2 = \dots = c_n = 0$ .

Thus, it remains to show that (i) implies (iv). Assume that (i) holds. Then there exist a smallest  $1 \leq m \leq n$  and  $c_0, \dots, c_m \in \mathbb{R}$  such that  $c_0^2 + c_1^2 + \dots + c_m^2 > 0$  and

$$(4.17) \quad c_0x + c_1d_1(x) + \dots + c_md_m(x) = 0 \quad (x \in \mathbb{R}).$$

This means that the equality

$$\gamma_0x + \gamma_1d_1(x) + \dots + \gamma_{m-1}d_{m-1}(x) = 0 \quad (x \in \mathbb{R})$$

can only hold for  $\gamma_0 = \dots = \gamma_{m-1} = 0$ .

Observe, that  $d_1(1) = \dots = d_n(1) = 0$ . Indeed,  $d_1(1) = 0$  is a consequence of (4.2) when  $k = 1$  because this equation means that  $d_1$  is a derivation. The rest easily follows by induction on  $k$  from (4.2).

Putting  $x = 1$  into (4.17), it follows that  $c_0 = 0$ . If  $m = 1$ , then  $c_1$  cannot be zero, hence we obtain that  $d_1 = 0$ . Thus, we may assume that the minimal  $m$  for which (4.17) is satisfied is non-smaller than 2. Replacing  $x$  by  $xy$  in (4.17) and applying (4.2), for all  $x, y \in \mathbb{R}$ , we get

$$\begin{aligned} 0 &= \sum_{k=1}^m c_k d_k(xy) = \sum_{k=1}^m c_k \left( \sum_{i=0}^k \Gamma(i, k-i) d_i(x) d_{k-i}(y) \right) \\ &= \sum_{k=2}^m c_k \left( \sum_{i=1}^{k-1} \Gamma(i, k-i) d_i(x) d_{k-i}(y) \right) + x \left( \sum_{k=1}^m c_k d_k(y) \right) + y \left( \sum_{k=1}^m c_k d_k(x) \right) \\ &= \sum_{k=2}^m \sum_{i=1}^{k-1} c_k \Gamma(i, k-i) d_i(x) d_{k-i}(y) = \sum_{i=1}^{m-1} \sum_{k=i+1}^m c_k \Gamma(i, k-i) d_i(x) d_{k-i}(y) \\ &= \sum_{i=1}^{m-1} \left( \sum_{j=1}^{m-i} c_{i+j} \Gamma(i, j) d_j(y) \right) d_i(x). \end{aligned}$$

By the minimality of  $m$ , it follows from the above equality that, for all  $y \in \mathbb{R}$ ,

$$\sum_{j=1}^{m-i} c_{i+j} \Gamma(i, j) d_j(y) = 0 \quad (i \in \{1, \dots, m-1\}).$$

Again, by the minimality of  $m$ , this implies that  $c_{i+j} \Gamma(i, j) = 0$  for  $(i, j) \in \Delta_m$  with  $i, j \geq 1$ . By the assumption of the theorem, for all  $k \in \{2, \dots, n\}$  there exists  $i \in \{1, \dots, k-1\}$  such that  $\Gamma(i, k-i) \neq 0$ . Thus,  $c_2 = \dots = c_m = 0$ . Therefore, by (4.17),  $c_1$  cannot be equal to zero. Then (4.17) simplifies to  $d_1 = 0$ , which was to be proved.  $\square$

Let  $n \in \mathbb{N}$  be arbitrary and  $d: \mathbb{R} \rightarrow \mathbb{R}$  be a derivation. Then the  $(n+1)$ -tuple  $(id, d, d^2, \dots, d^n)$  is a derivation of order  $n$ . Thus from the previous theorem we immediately get the following.

**Corollary 4.4.1** *Let  $n \in \mathbb{N}$  and let  $d: \mathbb{R} \rightarrow \mathbb{R}$  be a derivation. Then the following statements are equivalent:*

(i) *there exist  $c_0, c_1, \dots, c_n \in \mathbb{R}$  such that  $c_0^2 + c_1^2 + \dots + c_n^2 > 0$  and*

$$c_0 x + c_1 d(x) + \dots + c_n d^n(x) = 0 \quad (x \in \mathbb{R});$$

(ii) *there exists an upper semicontinuous function  $\Phi: \mathbb{R}^{n+1} \rightarrow \mathbb{R}$  such that  $\Phi \not\equiv 0$  and*

$$\Phi(x, d(x), \dots, d^n(x)) \geq 0 \quad (x \in \mathbb{R});$$

(iii) *the set  $\{(x, d(x), \dots, d^n(x)) \mid x \in \mathbb{R}\}$  is not dense in  $\mathbb{R}^{n+1}$ ;*

(iv)  *$d = 0$ .*



# Chapter 5

## Characterization of derivations by actions on certain elementary function

### 5.1 Introduction and preparatory statements

It is easy to see from Definition 2.1.1 that every derivation  $f: \mathbb{R} \rightarrow \mathbb{R}$  satisfies the equation

$$(5.1) \quad f(x^k) = kx^{k-1}f(x) \quad (x \in \mathbb{R} \setminus \{0\})$$

for arbitrarily fixed  $k \in \mathbb{Z} \setminus \{0\}$ . Furthermore, the converse is also true, in the following sense: if  $k \in \mathbb{Z} \setminus \{0, 1\}$  is fixed and an additive function  $f: \mathbb{R} \rightarrow \mathbb{R}$  satisfies (5.1), then  $f$  is a derivation, see e.g., Jurkat [48], Kurepa [55], and Kannappan–Kurepa [49].

Motivated by a problem of I. Halperin (1963), Jurkat [48] and, independently, Kurepa [55] proved that every additive function  $f: \mathbb{R} \rightarrow \mathbb{R}$  satisfying

$$f\left(\frac{1}{x}\right) = \frac{1}{x^2}f(x) \quad (x \in \mathbb{R} \setminus \{0\})$$

has to be linear.

In [63] A. Nishiyama and S. Horinouchi investigated additive functions  $f: \mathbb{R} \rightarrow \mathbb{R}$  satisfying the additional equation

$$(5.2) \quad f(x^n) = cx^k f(x^m) \quad (x \in \mathbb{R} \setminus \{0\}),$$

where  $c \in \mathbb{R}$  and  $n, m, k \in \mathbb{Z}$  are arbitrarily fixed. This approach is obviously the common generalization of the abovementioned results. In the second part of this chapter we will deal with the stability of this last system of functional equations. Our main results could serve as a generalization of the theorems of [63].

We remark that in [4] Badora solved a stability problem for derivations mappings between Banach algebras. In this chapter we replace the Leibniz rule with an equation in a single variable, namely, with a member of the family of equations in the form (5.2). On the other hand, we restrict our considerations to real functions.

In order to avoid superfluous repetitions, henceforth we will say that the function in question is *locally regular* on its domain, if at least one of the following statements are fulfilled.

- (i) bounded on a measurable set of positive measure;
- (ii) continuous at a point;

(iii) there exists a set of positive Lebesgue measure so that the restriction of the function in question is measurable in the sense of Lebesgue.

Furthermore, a function will be called *globally regular*, if instead of (ii), (ii)' continuous on its domain holds.

Firstly we prove a simple lemma.

**Lemma 5.1.1** *Let  $\alpha \in \mathbb{R}$  be arbitrarily fixed and let us assume that for the function  $\phi: ]0, +\infty[ \rightarrow \mathbb{R}$  the following statements are valid.*

(a) *the function  $\phi$  is  $\mathbb{Q}$ -homogeneous of order  $\alpha$ , that is,*

$$\phi(rx) = r^\alpha \phi(x) \quad (x \in ]0, +\infty[, r \in \mathbb{Q} \cap ]0, +\infty[).$$

(b) *the function  $\phi$  is continuous at a point.*

*Then  $\phi$  is continuous everywhere.*

**Proof.** Let us assume that the function  $\phi$  is continuous at the point  $x_0 \in ]0, +\infty[$  and let  $\tilde{x} \in ]0, +\infty[$  be arbitrary. Then, there exists a sequence of positive rational numbers  $(r_n)_{n \in \mathbb{N}}$  so that  $\lim_{n \rightarrow \infty} r_n = \frac{\tilde{x}}{x_0}$ . In this case the sequence  $\left(\frac{1}{r_n}\right)_{n \in \mathbb{N}}$  is also a sequence of positive rational numbers and it converges to  $\frac{x_0}{\tilde{x}}$ . Due to property (a),

$$\frac{1}{r_n^\alpha} \phi(\tilde{x}) = \phi\left(\frac{\tilde{x}}{r_n}\right) \quad (n \in \mathbb{N}).$$

Taking the limit  $n \rightarrow \infty$ , the left hand side converges to  $\left(\frac{x_0}{\tilde{x}}\right)^\alpha \phi(\tilde{x})$ . Furthermore, the sequence  $\left(\frac{\tilde{x}}{r_n}\right)_{n \in \mathbb{N}}$  converges to  $x_0$ , therefore the continuity of the function  $\phi$  implies that the right hand side tends to  $\phi(x_0)$  as  $n \rightarrow \infty$ . This implies that

$$\left(\frac{x_0}{\tilde{x}}\right)^\alpha \phi(\tilde{x}) = \phi\left(\frac{x_0}{\tilde{x}} \tilde{x}\right)$$

is fulfilled. Since  $\tilde{x} \in ]0, +\infty[$  was arbitrary, we get that

$$\phi(\lambda x) = \lambda^\alpha \phi(x) \quad (\lambda, x \in ]0, +\infty[),$$

which obviously implies the (everywhere) continuity of the function  $\phi$ . □

Furthermore, it is important pointing out the following fact. Fix  $\alpha \in \mathbb{R}$  and let  $\phi: ]0, +\infty[ \rightarrow \mathbb{R}$  be a  $\mathbb{Q}$ -homogeneous function of order  $\alpha$ . Suppose that  $\phi$  fulfills property (i) or (iii) on the set of positive Lebesgue measure  $D$ . Then, the  $\mathbb{Q}$ -homogeneity of the function  $\phi$  implies that (i), respectively (iii) holds for the function  $\phi$  on the set  $r \cdot D$  for all  $r \in \mathbb{Q}$ .

During the proof of our results we will also utilize a theorem a Kannappan–Kurepa [49].

**Theorem 5.1.1** *Let  $f, g: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions and  $n, m \in \mathbb{Z} \setminus \{0\}$ ,  $n \neq m$ . Suppose that*

$$f(x^n) = x^{n-m} g(x^m)$$

*holds for all  $x \in \mathbb{R} \setminus \{0\}$ . Then the functions  $F, G: \mathbb{R} \rightarrow \mathbb{R}$  defined by*

$$F(x) = f(x) - f(1)x \quad \text{and} \quad G(x) = g(x) - g(1)x \quad (x \in \mathbb{R})$$

*are derivations and  $nF(x) = mG(x)$  is fulfilled for all  $x \in \mathbb{R}$ .*

## 5.2 Derivations along monomial functions

**Theorem 5.2.1** Let  $n, m \in \mathbb{Z} \setminus \{0\}$ ,  $n \neq m$  so that  $n = -m$  or  $\text{sign}(n) = \text{sign}(m)$ , let further  $f, g: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions. Define the function  $\phi: \mathbb{R} \setminus \{0\} \rightarrow \mathbb{R}$  by the formula

$$\phi(x) = f(x^n) - x^{n-m}g(x^m) \quad (x \in \mathbb{R} \setminus \{0\}),$$

and assume that  $\phi$  is locally regular. Then, the functions  $F, G: \mathbb{R} \rightarrow \mathbb{R}$  defined by

$$F(x) = f(x) - f(1)x \quad \text{and} \quad G(x) = g(x) - g(1)x \quad (x \in \mathbb{R})$$

are derivations and

$$nF(x) = mG(x)$$

holds for arbitrary  $x \in \mathbb{R}$ .

**Proof.** Concerning the values of  $n$  and  $m$  we have to distinguish three cases. At first, let us assume that  $n, m > 0$ . There is no loss of generality in assuming  $n > m$ . Define the function  $\Phi$  on  $\mathbb{R}^n$  by

$$\Phi(x_1, \dots, x_n) = f(x_1 \cdots x_n) - \frac{1}{\binom{n}{m}} \sum_{\text{card}(I)=m} \left( \prod_{j \in \{1, 2, \dots, n\} \setminus I} x_j \right) g \left( \prod_{i \in I} x_i \right) \quad (x_1, \dots, x_n \in \mathbb{R}),$$

where the summation is considered for all subsets  $I$  of cardinality  $m$  of the index set  $\{1, \dots, n\}$ . Due to the additivity of the functions  $f$  and  $g$ , the function  $\Phi$  is a symmetric and  $n$ -additive function. Furthermore, its trace, that is,

$$\Phi(x, \dots, x) = \phi(x) = f(x^n) - x^{n-m}g(x^m) \quad (x \in \mathbb{R})$$

is a polynomial function. On the other hand  $\phi$  is a locally regular function. In view of Theorems 1.6.7, 1.6.8, 1.6.9, 1.6.10, this means that  $\phi$  is a continuous polynomial function. Therefore, there exists  $c \in \mathbb{R}$  such that

$$\Phi(x_1, \dots, x_n) = cx_1 \cdots x_n \quad (x_1, \dots, x_n \in \mathbb{R}),$$

therefore,

$$\phi(x) = cx^n \quad (x \in \mathbb{R}).$$

With the substitution  $x = 1$ , we get  $\phi(1) = c$ . On the other hand, the definition of the function  $\phi$  yields that  $\phi(1) = f(1) - g(1)$ . Thus,

$$f(x^n) - x^{n-m}g(x^m) = [f(1) - g(1)]x^n \quad (x \in \mathbb{R}).$$

Define the functions  $F, G: \mathbb{R} \rightarrow \mathbb{R}$  by

$$F(x) = f(x) - f(1)x \quad \text{and} \quad G(x) = g(x) - g(1)x \quad (x \in \mathbb{R}).$$

Then the above identity yields that

$$F(x^n) = x^{n-m}G(x^m) \quad (x \in \mathbb{R}).$$

The statement of the theorem follows now from Theorem 5.1.1.

Secondly, let us assume that  $n, m < 0$ . In this case we get that the function

$$\phi(x) = f(x^n) - x^{n-m}g(x^m) \quad (x \in \mathbb{R} \setminus \{0\})$$

is locally regular on its domain. Let  $u \in \mathbb{R} \setminus \{0\}$ , with the substitution  $x = \frac{1}{u}$  this yields that

$$\phi\left(\frac{1}{u}\right) = f(u^{-n}) - u^{-(n-m)}g(u^{-m}) \quad (u \in \mathbb{R} \setminus \{0\}).$$

Since  $-n, -m > 0$ , the results of the previous case can be applied for the function

$$\psi(u) = \phi\left(\frac{1}{u}\right) \quad (u \in \mathbb{R} \setminus \{0\}),$$

which is, due to the local regularity of  $\phi$ , also locally regular.

Finally, let us assume that  $n = -m$ . Without the loss of generality  $m > 0$  can be assumed. In this case

$$\phi(x) = f(x^{-m}) - x^{-2m}g(x^m) \quad (x \in \mathbb{R} \setminus \{0\})$$

is locally regular, or equivalently, the mapping

$$(5.3) \quad \psi(x) = \phi\left(\sqrt[m]{x}\right) = f\left(\frac{1}{x}\right) - \frac{1}{x^2}g(x) \quad (x > 0)$$

has the local regularity property. Let  $u > 0$  be arbitrary and let us substitute  $u(u+1)$  in place of  $x$ . Then

$$\begin{aligned} \psi(u(u+1)) &= \phi\left(\sqrt[m]{u(u+1)}\right) \\ &= f\left(\frac{1}{u(u+1)}\right) - \frac{1}{u^2(u+1)^2}g(u(u+1)) \end{aligned} \quad (u > 0).$$

Using the additivity of the function  $f$ ,

$$\begin{aligned} \psi(u(u+1)) &= \phi\left(\sqrt[m]{u(u+1)}\right) \\ &= f\left(\frac{1}{u}\right) - f\left(\frac{1}{u+1}\right) - \frac{1}{u^2(u+1)^2}g(u(u+1)) \end{aligned} \quad (u > 0).$$

On the other hand,

$$\psi(u) = \phi\left(\sqrt[m]{u}\right) = f\left(\frac{1}{u}\right) - \frac{1}{u^2}g(u) \quad (u > 0)$$

and

$$\psi(u+1) = \phi\left(\sqrt[m]{u+1}\right) = f\left(\frac{1}{u+1}\right) - \frac{1}{(u+1)^2}g(u+1) \quad (u > 0).$$

Therefore,

$$\begin{aligned} \psi(u(u+1)) - \psi(u) + \psi(u+1) &= \phi\left(\sqrt[m]{u(u+1)}\right) - \phi\left(\sqrt[m]{u}\right) + \phi\left(\sqrt[m]{u+1}\right) \\ &= f\left(\frac{1}{u}\right) - f\left(\frac{1}{u+1}\right) - \frac{1}{u^2(u+1)^2}g(u(u+1)) \\ &\quad - f\left(\frac{1}{u}\right) + \frac{1}{u^2}g(u) + f\left(\frac{1}{u+1}\right) - \frac{1}{(u+1)^2}g(u+1) \end{aligned} \quad (u > 0)$$

Making use of the additivity of the function  $g$ , after rearrangement, we obtain that

$$\chi(u) = 2ug(u) - g(u^2) \quad (u > 0),$$

where

$$\chi(u) = u^2(u+1)^2 [\psi(u(u+1)) - \psi(u) + \psi(u+1)] + u^2g(1) \quad (u > 0).$$

By our assumptions, the function  $\phi$  is locally regular on  $\mathbb{R} \setminus \{0\}$  and due to the additivity of  $f$  and  $g$ , it is  $\mathbb{Q}$ -homogeneous of order  $n$ . Thus, by Lemma 5.1.1,  $\phi$  is globally regular on  $\mathbb{R} \setminus \{0\}$ . This implies that  $\psi$  is globally regular on  $]0, +\infty[$ , which means that  $\chi$  is locally regular. Due to the results of the first case this yields that the function  $G: \mathbb{R} \rightarrow \mathbb{R}$  defined by

$$G(x) = g(x) - g(1)x \quad (x \in \mathbb{R})$$

is a derivation. In view of (5.3), this implies that

$$\phi\left(\sqrt[m]{x}\right) = f\left(\frac{1}{x}\right) - \frac{1}{x^2} [G(x) + g(1)x] \quad (x > 0),$$

that is ,

$$\phi\left(\sqrt[m]{x}\right) = f\left(\frac{1}{x}\right) + G\left(\frac{1}{x}\right) + g(1)\frac{1}{x} \quad (x > 0),$$

since  $G$  is a derivation. Let  $u > 0$ , with the substitution  $x = \frac{1}{u}$  we get that

$$\psi(u) = \phi\left(\sqrt[m]{\frac{1}{u}}\right) = f(u) + G(u) + g(1)u \quad (u > 0).$$

Let us observe that the right hand side of this identity is an additive function, being the sum of additive functions. Moreover, the left hand side is locally regular, due to the local regularity of  $\phi$ . Thus  $\psi$  is a regular additive function, which means that there exists  $c \in \mathbb{R}$  so that

$$f(u) + G(u) + g(1)u = cu \quad (u \in \mathbb{R}).$$

With  $u = 1$ ,  $c = f(1) + g(1)$  can be obtained, therefore,

$$f(u) = [f(1) + g(1)]u - g(1)u + G(u) \quad (u \in \mathbb{R}),$$

i.e.,

$$f(u) = -G(u) + f(1)u \quad (u \in \mathbb{R}).$$

This means that the function  $F: \mathbb{R} \rightarrow \mathbb{R}$  defined by

$$F(x) = f(x) - f(1)x \quad (x \in \mathbb{R})$$

is a derivation and

$$F(x) = -G(x) \quad (x \in \mathbb{R})$$

holds. □

**Lemma 5.2.1** Let  $\kappa \in \mathbb{R}$ ,  $n, m \in \mathbb{Z}$ ,  $n \neq m$  and assume that  $f: \mathbb{R} \rightarrow \mathbb{R}$  is an additive function. Define the function  $\phi: \mathbb{R} \setminus \{0\} \rightarrow \mathbb{R}$  by

$$\phi(x) = f(x^n) - \kappa x^{n-m} f(x^m) \quad (x \in \mathbb{R} \setminus \{0\})$$

and assume that  $\phi$  is locally regular. Then, the function  $F: \mathbb{R} \rightarrow \mathbb{R}$  defined by

$$F(x) = f(x) - f(1)x \quad (x \in \mathbb{R} \setminus \{0\})$$

is a derivation so that for any  $x \in \mathbb{R}$

$$(n - \kappa m) F(x) = 0.$$

**Proof.** In view of the previous theorem, it is enough to deal with the case  $\text{sign}(n) \neq \text{sign}(m)$  and  $n \neq -m$ . Due to the definition of the function  $\phi$

$$\phi(x^n) = f(x^{n^2}) - \kappa x^{n(n-m)} f(x^{nm}) \quad (x \in \mathbb{R} \setminus \{0\})$$

and

$$\phi(x^m) = f(x^{nm}) - \kappa x^{m(n-m)} f(x^{m^2}) \quad (x \in \mathbb{R} \setminus \{0\}),$$

therefore

$$\phi(x^n) + \kappa x^{n(n-m)} \phi(x^m) = f(x^{n^2}) - \kappa^2 x^{n^2-m^2} f(x^{m^2}) \quad (x \in \mathbb{R} \setminus \{0\}).$$

By our assumptions,  $\phi$  is a locally regular function on  $\mathbb{R} \setminus \{0\}$ . However, the additivity of  $f$  implies that

$$\phi(rx) = r^n \phi(x) \quad (x \in \mathbb{R} \setminus \{0\}, r \in \mathbb{Q} \setminus \{0\}).$$

Using Lemma 5.1.1, we get that  $\phi$  is globally regular. Therefore, the function

$$\psi(x) = \phi(x^n) + \kappa x^{n(n-m)} \phi(x^m) \quad (x \in \mathbb{R} \setminus \{0\})$$

is locally regular. Since  $n^2, m^2 > 0$  and  $n^2 \neq m^2$ , the results of the previous theorem can be applied (with the choice  $\psi(x) = \phi(x^n) + \kappa x^{n(n-m)} \phi(x^m)$  and  $g(x) = \kappa^2 f(x)$ ) to obtain that

$$f(x) = F(x) + f(1)x \quad (x \in \mathbb{R}),$$

where  $F: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation and

$$nF(x) = m\kappa F(x)$$

is also fulfilled for all  $x \in \mathbb{R}$ . □

From this lemma, the following corollary can be concluded immediately.

**Corollary 5.2.1** Let  $r \in \mathbb{Q} \setminus \{0, 1\}$  be arbitrarily fixed and  $f: \mathbb{R} \rightarrow \mathbb{R}$  be an additive function and define the function by

$$\phi(x) = f(x^r) - rx^{r-1} f(x) \quad (x \in \mathbb{R}, x > 0),$$

and assume that  $\phi$  is locally regular. Then, the function  $F: \mathbb{R} \rightarrow \mathbb{R}$  defined by

$$F(x) = f(x) - f(1)x \quad (x \in \mathbb{R})$$

is a derivation.

### 5.3 Derivations along rational functions

In view of the results of the previous subsection, we are able to prove the following. The results presented here can be considered as a generalization that of Halter-Koch–Reich [37, 38, 39].

**Theorem 5.3.1** *Let  $n \in \mathbb{Z} \setminus \{0\}$  and  $\begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \mathbf{GL}_2(\mathbb{Q})$  be such that*

- if  $c = 0$ , then  $n \neq 1$ ;
- if  $d = 0$ , then  $n \neq -1$ .

*Let further  $f, g: \mathbb{R} \rightarrow \mathbb{R}$  be additive functions and define the function  $\phi$  by*

$$\phi(x) = f\left(\frac{ax^n + b}{cx^n + d}\right) - \frac{x^{n-1}g(x)}{(cx^n + d)^2} \quad (x \in \mathbb{R}, cx^n + d \neq 0).$$

*Let us assume  $\phi$  to be globally regular. Then, the functions  $F, G: \mathbb{R} \rightarrow \mathbb{R}$  defined by*

$$F(x) = f(x) - f(1)x \quad \text{and} \quad G(x) = g(x) - g(1)x \quad (x \in \mathbb{R})$$

*are derivations.*

**Proof.** Firstly, let us suppose that  $c = 0$ . This means that the function

$$\phi(x) = f\left(\frac{a}{d}x^n + \frac{b}{d}\right) - \frac{1}{d^2}x^{n-1}g(x) \quad (x \in \mathbb{R} \setminus \{0\})$$

is globally regular. In this case, the statement immediately follows from Theorem 5.2.1.

Similarly, if  $d = 0$ , then

$$\phi(x) = f\left(\frac{a}{c} + \frac{b}{c}x^{-n}\right) - x^{-n-1}g(x) \quad (x \in \mathbb{R} \setminus \{0\})$$

is globally regular. Therefore, due to Theorem 5.2.1, we obtain that the functions

$$F(x) = f(x) - f(1)x \quad \text{and} \quad G(x) = g(x) - g(1)x \quad (x \in \mathbb{R})$$

are derivations.

Thus, henceforth  $cd \neq 0$  can be assumed. Furthermore, due to the  $\mathbb{Q}$ -homogeneity of the functions  $f$  and  $g$ ,  $c = 1$  can be supposed. That is,

$$\phi(x) = f\left(\frac{ax^n + b}{x^n + d}\right) - \frac{x^{n-1}g(x)}{(x^n + d)^2} \quad (x \in \mathbb{R}, x^n + d \neq 0).$$

Since the function  $f$  is additive,

$$f\left(\frac{ax^n + b}{x^n + d}\right) = f(a) - f\left(\frac{D}{x^n + d}\right), \quad (x \in \mathbb{R}, x^n + d \neq 0),$$

therefore,

$$(5.4) \quad \phi(x) = f(a) - f\left(\frac{D}{x^n + d}\right) - \frac{x^{n-1}g(x)}{(x^n + d)^2} \quad (x \in \mathbb{R}, x^n + d \neq 0),$$

where  $D = \det \begin{pmatrix} a & b \\ 1 & d \end{pmatrix}$ . Let us observe that

$$\frac{D}{x^n + d} = \frac{D}{d} - \frac{D}{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d}$$

holds for all  $x \in \mathbb{R}$ ,  $x \neq 0$ ,  $x^n + d \neq 0$ . Using this identity, we receive

$$(5.5) \quad \phi(x) = f(a) - f\left(\frac{D}{d}\right) + f\left(\frac{D}{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d}\right) - \frac{x^{n-1}g(x)}{(x^n + d)^2}$$

$(x \in \mathbb{R}, x \neq 0, x^n + d \neq 0),$

where the additivity of the function  $f$  was also used. Let us replace  $x$  by  $\sqrt[n]{d^2 \frac{1}{x}}$  in (5.4) to acquire

$$\phi\left(\sqrt[n]{d^2 \frac{1}{x}}\right) = f(a) - f\left(\frac{D}{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d}\right) - \frac{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^{n-1} g\left(\sqrt[n]{d^2 \frac{1}{x}}\right)}{\left(\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d\right)^2}$$

$(x \in \mathbb{R}, x \neq 0, x^n + d \neq 0).$

Since

$$\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d = d \frac{1}{x^n} (x^n + d),$$

the above identity yields that

$$\phi\left(\sqrt[n]{d^2 \frac{1}{x}}\right) = f(a) - f\left(\frac{D}{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d}\right) - \frac{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^{n-1} g\left(\sqrt[n]{d^2 \frac{1}{x}}\right)}{\left(d \frac{1}{x^n}\right)^2 (x^n + d)^2}$$

$(x \in \mathbb{R}, x \neq 0, x^n + d \neq 0).$

After some rearrangement, we arrive at

$$(5.6) \quad \phi\left(\sqrt[n]{d^2 \frac{1}{x}}\right) = f(a) - f\left(\frac{D}{\left(\sqrt[n]{d^2 \frac{1}{x}}\right)^n + d}\right) - \frac{x^{n-1} \frac{1}{\sqrt[n]{d^2}} x^2 g\left(\sqrt[n]{d^2 \frac{1}{x}}\right)}{(x^n + d)^2}$$

$(x \in \mathbb{R}, x \neq 0, x^n + d \neq 0).$

In case we add (5.5) and (5.6) together,

$$\phi(x) + \phi\left(\sqrt[n]{d^2 \frac{1}{x}}\right) = f\left(2a - \frac{D}{d}\right) - \frac{x^{n-1}}{(x^n + d)^2} \left[ g(x) + x^2 \frac{1}{\sqrt[n]{d^2}} g\left(\sqrt[n]{d^2 \frac{1}{x}}\right) \right]$$

$(x \in \mathbb{R}, x \neq 0, x^n + d \neq 0).$

Let us define the functions

$$h(x) = \frac{1}{\sqrt[n]{d^2}} g\left(\sqrt[n]{d^2} x\right) \quad (x \in \mathbb{R})$$



and

$$\psi(x) = -\frac{1}{x^2} \frac{(x^n + d)^2}{x^{n-1}} \left[ \phi(x) + \phi\left(\sqrt[n]{d^2} \frac{1}{x}\right) - f\left(2a - \frac{D}{d}\right) \right]$$

$(x \in \mathbb{R}, x \neq 0, x^n + d \neq 0).$

In this case

$$\psi(x) = h\left(\frac{1}{x}\right) + \frac{1}{x^2}g(x) \quad (x \in \mathbb{R}, x \neq 0, x^n + d \neq 0)$$

holds. By our assumptions  $\phi$  is a globally regular mapping, therefore the function  $\psi$  has the local regularity property. Due to Theorem 5.2.1, this gives that the functions  $F, G: \mathbb{R} \rightarrow \mathbb{R}$  defined by

$$F(x) = f(x) - f(1)x \quad \text{and} \quad G(x) = g(x) - g(1)x \quad (x \in \mathbb{R})$$

are derivations. □

## 5.4 A characterization of linearity

Finally, in the last part of this chapter we present a characterization of linearity. Just as in the proof of Theorem 5.3.1, Theorem 5.2.1 plays again an important role.

**Theorem 5.4.1** *Let  $n \in \mathbb{N}$ ,  $n \neq 1$  and  $f: \mathbb{R} \rightarrow \mathbb{R}$  be an additive function. Define  $\phi$  on  $\mathbb{R}$  by*

$$\phi(x) = f(x^n) - f(x)^n \quad (x \in \mathbb{R}).$$

*Let us assume that  $\phi$  is locally regular. Then the function  $f$  is linear, that is,*

$$f(x) = f(1)x$$

*holds for all  $x \in \mathbb{R}$ .*

**Proof.** Let us define the function  $\Phi: \mathbb{R}^n \rightarrow \mathbb{R}$  by

$$\Phi(x_1, \dots, x_n) = f(x_1 \cdots x_n) - f(x_1) \cdots f(x_n) \quad (x_1, \dots, x_n \in \mathbb{R}).$$

Due to the additivity of  $f$ , the function  $\Phi$  is a symmetric,  $n$ -additive function. Furthermore,

$$\Phi(x, \dots, x) = \phi(x) = f(x^n) - f(x)^n \quad (x \in \mathbb{R}).$$

From the local regularity of the function  $\phi$  we immediately deduce that  $\phi$  is a continuous polynomial function. Consequently,

$$(5.7) \quad \Phi(x_1, \dots, x_n) = cx_1 \cdots x_n \quad (x_1, \dots, x_n \in \mathbb{R})$$

holds with a certain  $c \in \mathbb{R}$ . Due to the definition of the function  $\phi$ , we have  $\phi(1) = f(1) - f(1)^n$ . On the other hand

$$\phi(1) = \Phi(1, \dots, 1) = c.$$

Hence  $c = f(1) - f(1)^n$ . Let  $u \in \mathbb{R}$ , with the substitution

$$x_1 = u, \quad x_i = 1 \text{ for } i \geq 2,$$

equation (5.7) yields that

$$f(u) - f(u)f(1)^{n-1} = (f(1) - f(1)^n)u \quad (u \in \mathbb{R}).$$

In case  $f(1)^{n-1} \neq 1$ , this furnishes

$$f(u) = f(1)u \quad (u \in \mathbb{R}).$$

If  $f(1)^{n-1} = 1$ , then

$$c = f(1) - f(1)^n = f(1) [1 - f(1)^{n-1}] = 0.$$

Therefore equation (5.7) with the substitutions

$$x_1 = u, \quad x_2 = v, \quad \text{and} \quad x_i = 1 \quad \text{for } i \geq 3 \quad (u, v \in \mathbb{R})$$

yields that

$$f(uv) = f(u)f(v)f(1)^{n-2} \quad (u, v \in \mathbb{R}),$$

that is,  $f(1)^{n-2} \cdot f$  is a non identically zero real homomorphism. In view of Kuczma [54, Theorem 14.4.1.] this implies that

$$f(1)^{n-2}f(u) = u \quad (u \in \mathbb{R}).$$

Since  $f(1)^{n-2} \cdot f(1) = f(1)^{n-1} = 1$ ,

$$\frac{f(u)}{f(1)} = u$$

holds for all  $u \in \mathbb{R}$ , that is,  $f$  is a linear function, indeed. □

**Definition 5.4.1** *Let  $R, R'$  be rings,  $n \in \mathbb{N}, n \geq 2$  be fixed. The function  $\varphi: R \rightarrow R'$  is called an  $n$ -homomorphism if*

$$\varphi(a + b) = \varphi(a) + \varphi(b) \quad (a, b \in R)$$

and

$$\varphi(a_1 \cdots a_n) = \varphi(a_1) \cdots \varphi(a_n) \quad (a_1, \dots, a_n \in R).$$

*The function  $\varphi: R \rightarrow R'$  is called an  $n$ -Jordan homomorphism if*

$$\varphi(a + b) = \varphi(a) + \varphi(b) \quad (a, b \in R)$$

and

$$\varphi(a^n) = \varphi(a)^n \quad (a \in R).$$

It was G. Ancochea who firstly dealt with the connection of Jordan homomorphisms and homomorphisms, see [3]. The results of G. Ancochea were generalized and extended in several ways, see for instance Jacobson–Rickart [45], Kaplansky [51], Żelazko [75].

In Gselmann [32] we proved a generalization of of the above result, namely the following theorems.

**Theorem 5.4.2** *Let  $n \in \mathbb{N}, n \geq 2$   $R$  be a ring,  $R'$  be a locally convex algebra over the field  $\mathbb{F}$  of characteristic zero,  $\varphi: R \rightarrow R'$  be an additive function and assume that the mapping*

$$R \ni x \longmapsto \varphi(x^n) - \varphi(x)^n$$

*is bounded on  $R$ . Then the function  $\varphi$  is an  $n$ -Jordan homomorphism.*

**Theorem 5.4.3** Let  $n \in \mathbb{N}, n \geq 2$ ,  $\mathbb{F}$  be a field of characteristic zero,  $R$  be a commutative topological ring and  $R'$  be a commutative topological algebra over the field  $\mathbb{F}$ . Furthermore, let us consider the additive function  $\varphi: R \rightarrow R'$  and suppose that for the map  $\phi$  defined on  $R$  by

$$\phi(x) = \varphi(x^n) - \varphi(x)^n \quad (x \in R)$$

one of the following statements hold.

- (i) the function  $\phi$  is continuous at a point;
- (ii) assuming that  $R'$  is locally convex, the function  $\phi$  is bounded on a nonvoid open set of  $B$ ;
- (iii) assuming that  $R$  is locally compact,  $R'$  is locally convex, the function  $\phi$  is bounded on a measurable set of positive measure;
- (iv) assuming that  $R$  is locally compact and  $R'$  is locally bounded and locally convex, the function  $\phi$  is measurable on a measurable set of positive measure.

Then and only then the function  $\varphi$  is a continuous function or it is an  $n$ -homomorphism.

## 5.5 Derivations along elementary functions

Roughly speaking the above presented results dealt with particular cases of the following problem. Assume that  $\xi$  is a given differentiable function and for the additive function  $d: \mathbb{R} \rightarrow \mathbb{R}$ , the mapping

$$x \mapsto d(\xi(x)) - \xi'(x)d(x)$$

is regular on its domain. It is true that in case  $d$  admits a representation

$$d(x) = \chi(x) + d(1) \cdot x \quad (x \in \mathbb{R}),$$

where  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a real derivation?

In view of the above results, in case  $n \in \mathbb{Z} \setminus \{0\}$  and  $\begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \mathbf{GL}_2(\mathbb{Q})$  and the function  $\xi$  is

$$\xi(x) = \frac{ax^n + b}{cx^n + d} \quad (x \in \mathbb{R}, cx^n + d \neq 0),$$

then the answer is *affirmative*. The main aim of this section is to extend this result to other classes of elementary functions such as the exponential function, the logarithm function, the trigonometric functions and the hyperbolic functions. Concerning such type of investigations, we have to mention the paper of Gy. Maksa (see [58]), where the previous problem was investigated under the supposition that the mapping

$$x \mapsto d(\xi(x)) - \xi'(x)d(x)$$

is identically zero.

Our main result in this section is contained in the following.

**Theorem 5.5.1** Assume that for the additive function  $d: \mathbb{R} \rightarrow \mathbb{R}$  the mapping  $\varphi$  defined by

$$\varphi(x) = d(\xi(x)) - \xi'(x)d(x)$$

is regular. Then the function  $d$  can be represented as

$$d(x) = \chi(x) + d(1) \cdot x \quad (x \in \mathbb{R}),$$

where  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation, in any of the following cases

**Proof.** Case (a) Let  $a \in \mathbb{R} \setminus \{1\}$  be an arbitrary positive real number and suppose that the mapping  $\varphi$  defined by

$$\varphi(x) = d(a^x) - a^x \ln(a)d(x) \quad (x \in \mathbb{R})$$

is regular. An easy calculation shows that

$$\varphi(2x) - 2a^x \varphi(x) = d((a^x)^2) - 2a^x d(x) \quad (x \in \mathbb{R}),$$

that is

$$\varphi(2 \log_a(u)) - 2u\varphi(\log_a(u)) = d(u^2) - 2ud(u) \quad (u \in ]0, +\infty[).$$

Due to the regularity of the function  $\varphi$ , the mapping

$$]0, +\infty[ \ni u \mapsto \varphi(2 \log_a(u)) - 2u\varphi(\log_a(u))$$

is regular, too. Thus by Theorem 5.3.1,

$$d(x) = \chi(x) + d(1) \cdot x \quad (x \in \mathbb{R}),$$

where the function  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation.

Case (b) Assume now that for the additive function  $d: \mathbb{R} \rightarrow \mathbb{R}$ , the mapping  $\varphi$  defined on  $\mathbb{R}$  by

$$\varphi(x) = d(\cos(x)) + \sin(x)d(x) \quad (x \in \mathbb{R})$$

is regular. If so, then

$$\frac{\varphi(2x) - 4 \cos(x)\varphi(x) + d(1)}{2} = d(\cos^2(x)) - 2 \cos(x)d(x)$$

holds for all  $x \in \mathbb{R}$ . Let now  $u \in ]-1, 1[$  and write  $\arccos(u)$  in place of  $x$  to get

$$\frac{\varphi(2\arccos(u)) - 4u\varphi(\arccos(u)) + d(1)}{2} = d(u^2) - 2ud(u).$$

Again, due to the regularity of the function  $\varphi$ , the mapping

$$]-1, 1[ \ni u \mapsto \frac{\varphi(2\arccos(u)) - 4u\varphi(\arccos(u)) + d(1)}{2}$$

is regular, as well. Therefore, Theorem 5.3.1 again implies that

$$d(x) = \chi(x) + d(1) \cdot x \quad (x \in \mathbb{R}),$$

is fulfilled with a certain real derivation  $\chi: \mathbb{R} \rightarrow \mathbb{R}$ .

Case (c) Suppose that for the additive function  $d$ , the mapping

$$\varphi(x) = d(\sin(x)) - \cos(x)d(x) \quad (x \in \mathbb{R})$$

is regular. In this case

$$\begin{aligned} \varphi\left(x - \frac{\pi}{2}\right) &= d\left(\sin\left(x - \frac{\pi}{2}\right)\right) - \cos\left(x - \frac{\pi}{2}\right)d\left(x - \frac{\pi}{2}\right) \\ &\quad - d(\cos(x)) - \sin(x)d(x) + \sin(x)d\left(\frac{\pi}{2}\right), \end{aligned}$$

that is,

$$-\varphi\left(x - \frac{\pi}{2}\right) + \sin(x)d\left(\frac{\pi}{2}\right) = d(\cos(x)) + \sin(x)d(x) \quad (x \in \mathbb{R}).$$

In view of Case (b) this yields that the function  $d$  has the desired representation as stated.

Case (d) Assume the  $d: \mathbb{R} \rightarrow \mathbb{R}$  is an additive function and the mapping

$$\varphi(x) = d(\cosh(x)) - \sinh(x)d(x) \quad (x \in \mathbb{R})$$

is regular. The additivity of  $d$  and some addition formula of the cosh function furnish

$$\begin{aligned} \frac{\varphi(2x) - 4 \cosh(x)\varphi(x) + d(1)}{2} \\ = d(\cosh^2(x)) - 2 \cosh(x)d(\cosh(x)) \quad (x \in \mathbb{R}). \end{aligned}$$

Let now  $u \in ]1, +\infty[$  arbitrary and put  $x = \operatorname{arcosh}(u)$  into the previous identity to get

$$\frac{\varphi(2\operatorname{arcosh}(u)) - 4u\varphi(\operatorname{arcosh}(u)) + d(1)}{2} = d(u^2) - 2ud(u).$$

Since the function  $\varphi$  is regular, the mapping

$$]1, +\infty[ \ni u \mapsto \frac{\varphi(2\operatorname{arcosh}(u)) - 4u\varphi(\operatorname{arcosh}(u)) + d(1)}{2}$$

will also be regular. Therefore, Theorem 5.3.1 implies again the desired decomposition of the function  $d$ .

Case (e) Finally, assume the  $d: \mathbb{R} \rightarrow \mathbb{R}$  is an additive function so that

$$\varphi(x) = d(\sinh(x)) - \cosh(x)d(x) \quad (x \in \mathbb{R})$$

is regular. Let  $x, y \in \mathbb{R}$  be arbitrary, then

$$\begin{aligned} \varphi(x+y) &= d(\sinh(x+y)) - \cosh(x+y)d(x+y) \\ &= d(\sinh(x)\cosh(y)) + d(\sinh(y)\cosh(x)) \\ &\quad - [\sinh(x)\sinh(y) + \cosh(x)\cosh(y)]d(x+y) \\ &= d(\sinh(x)\cosh(y)) + d(\sinh(y)\cosh(x)) - \sinh(x)\sinh(y)d(x+y) \\ &\quad - \cosh(x)d(x)\cosh(y) - \cosh(x)\cosh(y)d(y) \end{aligned}$$

If we use the definition of the function  $\varphi$ , after some rearrangement, we arrive at

$$\begin{aligned} & \varphi(x+y) - \varphi(x) \cosh(y) - \varphi(y) \cosh(x) \\ &= d(\sinh(x) \cosh(y)) + d(\sinh(y) \cosh(x)) - \sinh(x) \sinh(y) d(x+y) \\ & \quad - \cosh(y) d(\sinh(x)) - \cosh(x) d(\sinh(y)) \end{aligned}$$

for all  $x, y \in \mathbb{R}$ . If we replace here  $y$  by  $-y$ ,

$$\begin{aligned} & \varphi(x-y) - \varphi(x) \cosh(y) - \varphi(-y) \cosh(x) \\ &= d(\sinh(x) \cosh(y)) - d(\sinh(y) \cosh(x)) + \sinh(x) \sinh(y) d(x-y) \\ & \quad - \cosh(y) d(\sinh(x)) + \cosh(x) d(\sinh(y)) \end{aligned}$$

can be concluded, where we have also used that the function  $\cosh$  is even and the function  $\sinh$  is odd. Adding this two identities side by side,

$$\begin{aligned} \Phi(x, y) &= 2d(\sinh(x) \cosh(y)) \\ & \quad + \sinh(x) \sinh(x) [d(x-y) - d(x+y)] - 2 \cosh(y) d(\sinh(x)) \end{aligned}$$

for any  $x, y \in \mathbb{R}$ , where

$$\begin{aligned} \Phi(x, y) &= \varphi(x+y) - \varphi(x) \cosh(y) - \varphi(y) \cosh(x) \\ & \quad + \varphi(x-y) - \varphi(x) \cosh(y) - \varphi(-y) \cosh(x) \quad (x, y \in \mathbb{R}). \end{aligned}$$

If we put  $x = \operatorname{arsinh}(1)$ , we get that

$$\begin{aligned} & \frac{\Phi(\operatorname{arsinh}(1), y) + 2 \cosh(y) d(1)}{2} \\ & \quad = d(\cosh(y)) - \sinh(y) d(y) \quad (y \in \mathbb{R}). \end{aligned}$$

Due to the regularity of the function  $\varphi$ , the mapping

$$\mathbb{R} \ni y \mapsto \frac{\Phi(\operatorname{arsinh}(1), y) + 2 \cosh(y) d(1)}{2}$$

is regular, too. Hence, Case (d) yields the desired form of the function  $d$ . □

In what follows, we would like to extend the list of the functions appearing in the previous statement. Therefore we prove the following.

**Lemma 5.5.1** *Let  $d: \mathbb{R} \rightarrow \mathbb{R}$  be an additive function,  $I \subset \mathbb{R}$  be a nonvoid open interval and  $\xi: I \rightarrow \mathbb{R}$  be a continuously differentiable function so that the derivative of the function  $\xi^{-1}: \xi(I) \rightarrow \mathbb{R}$  is nowhere zero. The mapping*

$$I \ni x \mapsto d(\xi(x)) - \xi'(x) d(x)$$

*is regular if and only if the mapping*

$$\xi(I) \ni u \mapsto d(\eta(u)) - \eta'(u) d(u)$$

*is regular, where  $\eta = \xi^{-1}$ .*

**Proof.** Assume that for the additive function  $d$ , we have that the mapping

$$\varphi(x) = d(\xi(x)) - \xi'(x)d(x) \quad (x \in I)$$

is regular. Let now  $u \in \xi(I)$  and put  $\xi^{-1}(u)$  in place of  $x$  to get

$$-\left(\xi^{-1}\right)'(u)\varphi(\xi^{-1}(u)) = d\left(\xi^{-1}(u)\right) - \left(\xi^{-1}\right)'(u)d(u).$$

Due to the regularity of  $\varphi$ , the mapping appearing in the left hand side is also regular, as stated.  $\square$

In view of Theorem 5.5.1 and Lemma 5.5.1, we immediately obtain the following theorem.

**Corollary 5.5.1** *Assume that for the additive function  $d: \mathbb{R} \rightarrow \mathbb{R}$  the mapping  $\varphi$  defined by*

$$\varphi(x) = d(\xi(x)) - \xi'(x)d(x)$$

*is regular. Then the function  $d$  can be represented as*

$$d(x) = \chi(x) + d(1) \cdot x \quad (x \in \mathbb{R}),$$

*where  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a derivation, in any of the following cases*

Finally, we remark that the power functions are missing from all of the above results even if the function  $\varphi$  is identically zero. Thus we formulate the following.

**Open Problem 4** *Let  $\alpha \in \mathbb{R} \setminus \{0, 1\}$  and assume that the additive function  $d: \mathbb{R} \rightarrow \mathbb{R}$  also fulfills*

$$d(x^\alpha) = \alpha x^{\alpha-1}d(x) \quad (x \in \mathbb{R}, x > 0)$$

*Prove or disprove that the function  $d$  is a derivation. Note that in case  $\alpha \in \mathbb{Q} \setminus \{0, 1\}$  then due to Theorem 5.3.1 the answer is affirmative, see the paper [6], as well.*

*Furthermore, we remark that the above identity certainly does not characterizes derivations among additive functions, since there exists  $\alpha \in \mathbb{R}$  and a derivation  $d: \mathbb{R} \rightarrow \mathbb{R}$  for which  $d$  does not differentiates the function  $x \mapsto x^\alpha$ . Indeed, if  $\alpha \in \mathbb{R}$  is an irrational algebraic number, then due to the Gelfond–Schneider theorem (see Gelfond [23])  $2^\alpha$  is transcendental. In view of Theorem 2.2.1, there exists a derivation  $d: \mathbb{R} \rightarrow \mathbb{R}$  so that  $d(2^\alpha) = 1$ . In such a situation however*

$$1 = d(2^\alpha) \neq \alpha 2^{\alpha-1}d(2) = 0,$$

*since  $d$  has to be identically zero on the set  $\operatorname{algcl}(\mathbb{Q})$ .*

Furthermore, we also have to emphasize that in contrast to the previous sections of this chapter, Theorem 5.5.1 and also Corollary 5.5.1 are not characterization theorems. Thus we ask for the solutions of the following.

**Open Problem 5** *Prove or disprove that real derivations differentiate the function  $\xi$  appearing in Theorem 5.5.1 and in Corollary 5.5.1.*

## Stability of derivations

As a starting point of the proof of the main result of this section the theorem of Hyers will be used. Originally this statement was formulated in terms of functions that are acting between Banach spaces, see Hyers [44]. However, we will use this theorem only in the particular case when the domain and the range are the set of reals. In this setting we have the following.

**Theorem 5.5.2** *Let  $\varepsilon \geq 0$  and suppose that the function  $f: \mathbb{R} \rightarrow \mathbb{R}$  fulfills the inequality*

$$|f(x + y) - f(x) - f(y)| \leq \varepsilon$$

*for all  $x, y \in \mathbb{R}$ . Then there exists an additive function  $a: \mathbb{R} \rightarrow \mathbb{R}$  such that*

$$|f(x) - a(x)| \leq \varepsilon$$

*holds for arbitrary  $x \in \mathbb{R}$ .*

In other words, Hyers' theorem states that if a function  $f: \mathbb{R} \rightarrow \mathbb{R}$  fulfills the inequality appearing above, then it can be represented as

$$f(x) = a(x) + b(x) \quad (x \in \mathbb{R}),$$

where  $a: \mathbb{R} \rightarrow \mathbb{R}$  is an additive and  $b: \mathbb{R} \rightarrow \mathbb{R}$  is a bounded function. Moreover, for all  $x \in \mathbb{R}$ , we also have  $|b(x)| \leq \varepsilon$ .

With the aid of Hyers' theorem and the results of the previous section, the following stability type result can be proved. Concerning stability properties of derivations the interested reader may consult Badora [4] and Boros–Gselmann [6].

**Theorem 5.5.3** *Let  $\varepsilon > 0$  be arbitrarily fixed,  $f: \mathbb{R} \rightarrow \mathbb{R}$  be a function and suppose that*

*(A) for all  $x, y \in \mathbb{R}$  we have*

$$|f(x + y) - f(x) - f(y)| \leq \varepsilon.$$

*(B) the mapping*

$$x \mapsto f(\xi(x)) - \xi'(x)f(x)$$

*is locally bounded on its domain, where the function  $\xi$  is one of the functions*

(a)	$a^x$	(f)	$\ln(x)$
(b)	$\cos(x)$	(g)	$\arccos(x)$
(c)	$\sin(x)$	(h)	$\arcsin(x)$
(d)	$\cosh(x)$	(i)	$\operatorname{arcosh}(x)$
(e)	$\sinh(x)$	(j)	$\operatorname{arsinh}(x)$ .



Then there exist  $\lambda \in \mathbb{R}$  and a real derivation  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  such that

$$|f(x) - [\chi(x) + \lambda \cdot x]| \leq \varepsilon$$

holds for all  $x \in \mathbb{R}$ .

**Proof.** Due to assumption (A), we immediately have that

$$f(x) = a(x) + b(x) \quad (x \in \mathbb{R}),$$

where  $a: \mathbb{R} \rightarrow \mathbb{R}$  is an additive and  $b: \mathbb{R} \rightarrow \mathbb{R}$  is a bounded function. If we use supposition (B), from this we get that the mapping

$$x \mapsto [a(\xi(x)) - \xi'(x)a(x)] + [b(\xi(x)) - \xi'(x)b(x)]$$

is locally bounded. From this however the local boundedness of the function

$$x \mapsto a(\xi(x)) - \xi'(x)a(x)$$

can be deduced. In view of the previous statements (see Theorem 5.5.1 and Corollary 5.5.1),

$$a(x) = \chi(x) + a(1) \cdot x \quad (x \in \mathbb{R})$$

is fulfilled for any  $x \in \mathbb{R}$ , where  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  is a real derivation. For the function  $f$  this means that there exists  $\lambda \in \mathbb{R}$  and a real derivation  $\chi: \mathbb{R} \rightarrow \mathbb{R}$  so that

$$f(x) = \chi(x) + \lambda \cdot x + b(x) \quad (x \in \mathbb{R}),$$

or equivalently

$$|f(x) - [\chi(x) + \lambda \cdot x]| \leq \varepsilon$$

is satisfied for any  $x \in \mathbb{R}$ . □
